

AN ORDINANCE BY
COUNCILMEMBER JOYCE SHEPERD

AN ORDINANCE TO AMEND CHAPTER 150, ARTICLE VIII,
SECTION 150-296 OF THE CODE OF ORDINANCES OF THE CITY
OF ATLANTA PROHIBITING CRUISING BY INCLUDING THE
PITTSBURGH COMMUNITY AREAS IDENTIFIED AS “NO
CRUISING ZONES”; TO REPEAL CONFLICTING ORDINANCES;
AND FOR OTHER PURPOSES.

WHEREAS, the city of Atlanta has formally established areas of “no cruising” to create additional safety measures on city streets and to protect citizens from unsafe and unwanted behavior; and

WHEREAS, the term “cruise or cruising” is defined in Section 150-296(a)(1) as to operate a motor vehicle, or to permit the operation of a motor vehicle under one’s care, custody, or control, so as to pass the same traffic points within a “no cruising zone” more than twice within any two (2) hour period; and

WHEREAS, residents in the Pittsburgh Community has requested that their streets be designated “no cruising” area and have detailed problems of unsafe and unwanted behavior associated with the cruising activity in the area; and

WHEREAS, these streets have been approved by the Department of Public Works’ Office of Transportation on the dates indicated on the attached documents as qualifying for the “no cruising zone” designation.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1: That Section 150-296(a)(1) of the Code of Ordinances of the City of Atlanta, Georgia is hereby amended to include the following streets in the Pittsburgh Community as no cruising zones” and the Mayor or his designee is authorized to install the appropriate signage:


