

We need to have approximately 20 desk chairs removed from our facility within the next couple weeks. These chairs are 10+ years old and are in poor-fair condition. We will handle the cost of removing these items, and would like for this email to serve as proper notification that we are surplusng these items. If the City of Atlanta would like to take possession of these chairs, they are entitled to do so under the Program Policy and Guidance, then let me know so that the arrangements can be made. The chairs that are being transferred to our division (Strategy & Special Projects) will be distributed between 2 precincts that are in dire need of chairs. All of the chairs except for one is in good working order and are gently used. They are ergonomic desk chairs on castors with the ability to raise with the use of an under seat lever all of the chairs also have arm rest.

The chairs are comparable to the Wrigley Series 24/7 Multifunction Chair product# ALE-WR42TFB108 (specs can be found in the Nelson Business Products, Inc. book on page 169).

We are estimating that the chairs are now valued to be \$2,000.00 total.
