**AN ORDINANCE AUTHORIZING THE MAYOR OR HIS DESIGNEE, ON BEHALF OF THE CITY OF ATLANTA, TO ACCEPT A GRANT IN THE AMOUNT OF TWENTY THOUSAND DOLLARS (\$20,000.00) OF GRANT FUNDS FROM THE GEORGIA GOVERNOR'S OFFICE OF WORKFORCE DEVELOPMENT; THE GRANT NO: 55-13-14-03-003 (JOB TRAINING GRANT FUND) BUDGET, ADDING ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF TWENTY THOUSAND DOLLARS (\$20,000.00) IN THE WORKFORCE INVESTMENT ACT (WIA) ADULT , OFFENDER RE-ENTRY PROGRAM, TO PROVIDE JOB TRAINING AND OTHER SKILLS TO LOCAL ADULT OFFENDERS ; AND FOR OTHER PURPOSES.**

**WHEREAS,** the purpose of the Workforce Investment Act ("WIA") is to provide Workforce Investment Activities through statewide and local workforce systems in order to increase employment, retention, the earnings of citizens, and the attainment of occupations skill for participants, thereby improving the quality of the workforce; and

**WHEREAS,** the Georgia Governor's Office of Workforce Development ("GOWD") has awarded the City of Atlanta ("City") through the Atlanta Workforce Development Agency ("AWDA) grant funds in the amount of Twenty Thousand (\$20,000.00), to expand, increase and operate job training activities in accordance to the Workforce Investment Act; and

**WHEREAS,** The Governor's Office of Workforce Development is making available this funding award for purposes to operate an Ex-Offender Re-Entry program. These funds will be made available for a period of time not to exceed eighteen months. These funds may not be used to duplicate currently available services, nor may they be used to replace funding streams currently in place for personnel, services, or resources. All applicable state and federal regulations regarding the use of WIA funds will still apply to the use of these funds; and

**WHEREAS,** the AWDA will be expected to utilize these funds in the development and implementation of an ex-offender, transitional pilot program. AWDA has committed to identify and provide services to 10 eligible transitioning ex-offenders. If the AWDA fails to identify and enroll 10 eligible participants, two thousand (\$2,000.00) dollars may be deducted from the grant award for each participant short of the enrollment requirement. Activities under this grant may include, but are not limited to:

- Case management services for these eligible ex-offender participants
  - Eligible employment services
  - Supportive services to reduce barriers to employment
  - Initial start-up costs associated with the development and initial implementation of this pilot program;
- and

**WHEREAS,** the AWDA will be expected to enroll and track these participants through the Georgia Work Ready Online Participant Portal. These participants will be considered local participants and will count towards local performance measure reporting. AWDA will be expected to meet any additional reporting requirements set forth by GOWD as a condition of this pilot program participation;

**WHEREAS**, AWDA recommends the City to accept the Adult Program Grant to support its initiative to expand in assisting adult workers with job training and employment assistance; and

**WHEREAS**, AWDA recommends increasing receipts of grant funds by adding to anticipations and appropriations in the amount of Twenty Thousand Dollars (\$20,000.00) in the WIA Adult program fund.

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:**

**Section 1:** The Mayor or his designee, on behalf of the City of Atlanta, is authorized to accept a State reallocation of recaptured funds grant in the amount of Twenty Thousand Dollars (\$20,000.00) from GOWD for the purpose of aiding Ex- Offenders with job training and employment assistance ; and

**Section 2:** That such documents as may be necessary be authorized to be executed by appropriate parties to effectuate said grant; and

**Section 3:** That the 2014 (Job Training Grant Fund) budget is hereby amended as follows:


