**AN ORDINANCE BY
COMMUNITY DEVELOPMENT/ HUMAN RESOURCES COMMITTEE**

AN ORDINANCE AMENDING ATLANTA CODE OF ORDINANCES SECTION 110-67 PROHIBITED CONDUCT, TO ALLOW FISHING AT CERTAIN DESIGNATED PONDS AND LAKES IN ALL CITY OF ATLANTA-PARKS; AND FOR OTHER PURPOSES.

WHEREAS, the Atlanta Code of Ordinances (the "Code") Section 110-67 Hunting and Fishing bans hunting and fishing in City of Atlanta ("City") parks; and

WHEREAS, for the enjoyment and use of the public, the Department of Parks and Recreation ("DPR") desires to allow fishing in any public park, except as posted by DPR, including Historic Fourth Ward Park and Dean Rusk Park as well as others, as authorized by Federal or State law; and

WHEREAS, the City currently follows the Georgia Department of Natural Resources Fishing Regulations and DPR desires to designate, at its discretion, that fishing, followed by catch-and-release may be permissible in ponds and lakes located in City parks; and

WHEREAS, the City desires to amend the Code to allow fishing in City parks.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:

SECTION 1: Atlanta Code of Ordinances Section 110-67 entitled "Hunting and Fishing", which previously read:

Sec. 110-67. Hunting and fishing.

No person shall hunt, shoot or fish in any public park, except as provided by law or rule and regulation.


Shall now read:

Sec. 110-67. Hunting and fishing.

- (a) No person shall hunt or shoot in any public park, except as expressly authorized by law or rule and regulation.
- (b) Fishing is permitted in designated ponds and lakes in public parks and as authorized by state law, except where prohibited by the city.

SECTION 2: All ordinances and resolutions in conflict herewith are hereby waived for purposes of this Ordinance only, and only to the extent of said conflict.
