TRANSFERRING TWELVE THOUSAND SIX HUNDRED EIGHTY THREE DOLLARS (\$12,683.00) FROM THE DISTRICT 11 COUNCILMEMBER CARRY FORWARD IN NON-DEPARTMENTAL RESERVES TO THE DISTRICT 11 COUNCIL MEMBER EXPENSE ACCOUNT; AND FOR OTHER PURPOSES.

WHEREAS, each Council District and Council Post is entitled to hire staff for the operation of Council offices, and

WHEREAS, Council District 11 has compensated a Council Aide from the Council Member Expense account, and

WHEREAS, the compensation paid to the Council Aide totals \$12,683.00 and has left a balance which is insufficient to cover the operating expenses of that office for the remainder of the year and needs to be replenished from Council Member Carry forward in Non Departmental Reserves, and

WHEREAS, the necessary steps have been taken to compensate the Council Aide as an "Extra Help Employee".

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA GEORGIA, as follows:
