A RESOLUTION TO RESCIND THE SETTLEMENT OF THE CLAIM OF JASON MCKENNON IN THE AMOUNT OF \$4,118.80 AGAINST THE CITY OF ATLANTA AND FOR OTHER PURPOSES.

WHEREAS, JASON MCKENNON has filed a property damage claim against the City of Atlanta seeking damages arising out of an automobile accident on October 21, 2011 at 247 Moreland Avenue; and

WHEREAS, the damage to JASON MCKENNON occurred when the vehicle in which he drove was struck by a police vehicle that "failed to yield when entering a roadway", and;

WHEREAS, the claimant has asserted damages in the amount of \$4,118.80 and has agreed to be paid this amount in full and complete satisfaction and settlement of his claim against the City of Atlanta; and


WHEREAS, the City Attorney recommended that the claim of JASON MCKENNON be settled for the sum of \$4,118.80; and

WHEREAS, the City Council adopted Resolution Number 12-R-0749 on June 4, 2012 authorizing payment to JASON MCKENNON by the City of Atlanta in satisfaction of any and all claims he may have stemming from damages sustained as a result of a vehicular accident on or about October 21, 2011 at 247 Moreland Avenue, and that the City Attorney received the appropriate executed releases; and

WHEREAS, the City subsequently received a subrogation claim for damages from JASON MCKENNON'S insurance company in the amount of \$4,118.80; and

WHEREAS, the City Attorney has recommended that the claim of JASON MCKENNON be adversed and the settlement for the sum of \$4,118.80 be rescinded.


