WHEREAS, the City of Atlanta ("City") and is experiencing a proliferation of litter, waste, and scrap tires in its neighborhoods; and

WHEREAS, Council District 5 is hosting a Tire Roundup on Saturday, April 26, 2014 from 9am- 1pm at 815 Old Flat Shoals Road; and

WHEREAS, Liberty Tire Recycling, LLC. ("Liberty Tire") has offered to support this effort by providing materials and labor to pickup and prepare the tires for recycling; and
