**WHEREAS**, the Atlanta City Council adopted on November 4, 2013 and approved without signature by Resolution 13-R-3632 on November 13, 2013, the 2014 Annual Action Plan of the Consolidated Plan (hereafter known as the "Plan") which set forth projects and allocations for projects funded by the Community Development Block ("CDBG") and Home Investment Partnership ("HOME") Programs; and


**WHEREAS**, various CDBG and HOME projects are assigned to the Department Planning and Community Development, Office of Housing; and

**WHEREAS**, the necessary environmental clearances have been obtained from the U.S. Department of Housing and Urban Development ("HUD"); and

**WHEREAS**, the City of Atlanta ("City") has received funds from HUD and must anticipate and appropriate the funds in the 2014 (Community Development Fund) Budget by \$2,086,846.00 and the 2014 (HOME Investment Trust Fund) Budget by \$1,446,701.00.  
**THE COUNCIL OF THE CITY OF ATLANTA HEREBY ORDAINS AS FOLLOWS:**

**Section 1:** That the 2014 Community Development Fund Budget and the 2014 HOME Investment Trust Fund Budget be and are hereby amended as shown on the Attachment 1.

**Section 2:** That all ordinances and parts of ordinances in conflict with this ordinance are hereby waived to the extent if the conflict.
