WHEREAS, on September 20, 1993 the Council of the City of Atlanta passed legislation to activate the City of Atlanta Solid Waste Management Authority pursuant to the Regional Solid Waste Management Authorities Act (Code 1981, § 12-8-50), enacted by Ga. (1990, p. 412, §1.); and

WHEREAS, The position on the Atlanta Solid Waste Management Authority to be held by an Atlanta City Council Member who is elected by the Council is currently vacant; and



NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1: That Council Member Joyce M. Sheperd is hereby elected by the Atlanta City Council to serve as its representative on the Board of Directors of the City of Atlanta Solid Waste Management Authority.
