AN ORDINANCE BY COUNCILMEMBER IVORY L. YOUNG, JR TO TRANSFER TWO THOUSAND DOLLARS (\$2,000.00) IN EXPENSES FROM THE DISTRICT 3 COUNCILMEMBER EXPENSE ACCOUNT TO THE DISTRICT 3 COUNCIL MEMBER NON-DEPARTMENTAL CARRY FORWARD ACCOUNT FOR A CONTRIBUTION MADE BY DISTRICT 3 ON BEHALF OF THE ATLANTA FIRE AND RESCUE DEPARTMENT AND TO AUTHORIZE A CONTRIBUTION IN THE AMOUNT OF TWENTY THOUSAND DOLLARS (\$20,000.00) IN SUPPORT OF HOSEA FEED THE HUNGRY; AND FOR OTHER PURPOSES.

WHEREAS, the District 3 Member has supported certain community based activities in the Atlanta community, and

WHEREAS, during the month of December the Council Member from District 3 made a contribution in the amount of Two Thousand Dollars (\$2,000.00) in support of the Atlanta Fire and Rescue Department's annual holiday event to benefit children of the City, and

WHEREAS, the contribution was made from the Council Member Expense account and upon approval of this legislation, the expense will be transferred to the Council Member Carry Forward, and

WHEREAS, the Council Member has expressed intent to provide financial support to Hosea Feed the Hungry in the amount of Twenty Thousand Dollars (\$20,000.00) and seeks authorization from the City Council to make this payment from the Council Member Carry Forward in Non Departmental Reserves.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA GEORGIA, as follows:

SECTION 1: That the Chief Financial Officer is authorized to transfer expenses used in support of the Atlanta Fire and Rescue Department's Holiday event, in the amount of Two Thousand Dollars (\$2,000.00) from 1001 (General Fund) 030203 (Council District 3) 5730004 (Councilmember Expense) 111000 (Governing Body) Council Member Ivory Lee Young.

SECTION 2: That the Chief Financial Officer is hereby authorized to make payment to Hosea Feed the Hungry, in the amount of Twenty Thousand Dollars (\$20,000.00), upon receipt of the appropriate invoice. Payment to be made from 1001 (General Fund) 200101 (NDP Reservation of Funds) 5790001 (Contingency Fund-unrestricted) 1512000(Accounting) Council Member Ivory Lee Young, J.

SECTION 3: That all ordinances and parts of ordinances in conflict herewith are hereby repealed.
