WHEREAS, the purpose of the Workforce Investment Act ("WIA") is to provide Workforce Investment Activities through statewide and local workforce systems in order to increase employment, retention, the earnings of citizens, and the attainment of occupations skill for participants, thereby improving the quality of the workforce; and

WHEREAS, the Georgia Governor's Office of Workforce Development ("GOWD") has awarded the City of Atlanta ("City") through the Atlanta Workforce Development Agency ("AWDA") an increased portion of grant funds in the amount of Six Thousand and Forty-Six dollars (\$6,046.00) for a total amount of One Million Six Hundred Fifty-Seven Thousand, Five Hundred and One dollars (\$1,657,501.00) of which includes the original modification award of One Million Six Hundred and Fifty One Thousand Four Hundred Fifty Five Dollars (\$1,651,455.00), to expand, increase and operate job training Activities in accordance to the Workforce Investment Act; and

WHEREAS, AWDA recommends the City to accept the Adult Program FY2013 Grant to support its initiative to expand in assisting adult workers with job training and employment assistance; and

WHEREAS, AWDA recommends amending the 2013-151 (Job Training Grant Fund) budget, and increasing the receipts by adding to anticipations and appropriations in the amount Six Thousand and Forty Six Dollars (\$6,046.00) in the WIA Adult fund, for a total amount of One Million Six Hundred Fifty Seven Thousand, Five Hundred and One Dollars (\$1,657,501.00)

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Section 1: The Mayor or his designee, on behalf of the City of Atlanta, is authorized to accept a State reallocation of recaptured funds grant in the amount of SIX THOUSAND AND FORTY-SIX DOLLARS (\$6,046.00) from GOWD for the purpose of aiding ADULTs with job training and employment assistance for a total of One Million Six Hundred Fifty Seven Thousand, Five Hundred and One dollars (\$1,657,501.00) ; and

Section 2: That such documents as may be necessary be authorized to be executed by appropriate parties to effectuate said grant; and

Section 3: That the FY 2013 (Job Training Grant Fund) budget is hereby amended as follows:
