**AN ORDINANCE BY PUBLIC SAFETY AND LEGAL ADMINISTRATION COMMITTEE AMENDING THE 2014 (INTERGOVERNMENTAL GRANT FUND) BUDGET, DEPARTMENT OF POLICE, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS, THE AMOUNT OF FIFTY-ONE THOUSAND, THREE HUNDRED FORTY-ONE DOLLARS (\$51,341.00), FOR MODIFICATIONS #2 AND #3 TO GRANT G13GA0003A (“GRANT”) FROM THE WHITE HOUSE OFFICE OF NATIONAL DRUG CONTROL POLICY (“ONDCP”), FOR THE PURPOSE OF CONTINUING THE ATLANTA HIGH INTENSITY DRUG TRAFFICKING AREA TASK FORCE (“ATLANTA HITDA”); TO DISRUPT AND DISMANTLE DRUG TRAFFICKING ORGANIZATIONS; AND FOR OTHER PURPOSES.**

WHEREAS, the White House Office of National Drug Control Policy (“ONDCP”) grants funding to High Intensity Drug Trafficking Area (“HIDTA”) program task forces responsible for disrupting and dismantling violent drug trafficking organizations; and

WHEREAS, the Department of Police (“Department”) has been a participant in the Atlanta High Intensity Drug Trafficking Area task force (“Atlanta HIDTA”) for over ten years; and

WHEREAS, as per Resolution 05-R-0680, the Atlanta Police Department (“Department”) acts as the “pass through agency” to disburse payments for task force expenses that are completely federally funded, and with no matching funds; and

WHEREAS, the ONDCP has awarded the City grant G13GA0003A (“grant”), in the amount of two-million, five hundred thirty-three thousand, one hundred sixteen dollars (\$2,533,116.00), to continue funding the Atlanta HIDTA task force initiatives, and this award was approved by the City Council of Atlanta and the Mayor through ordinance 13-O-1034; and

WHEREAS, ONDCP modified grant award #G13GA0003A by adding modification #1 to the original grant award of an additional two million, six hundred twenty-five thousand, nine hundred forty-nine dollars (\$2,625,949) with no matching funds, bringing the grant award to a new total of five-million, one hundred fifty-nine thousand, sixty-five dollars (\$5,159,065.00) and this modification was approved by the City Council of Atlanta and the Mayor through 13-O-1176; and

WHEREAS, ONDCP further modified grant award #G13GA0003A with modification #2 which deducts nine thousand, one hundred fifty-nine dollars (-\$9,159.00) from the grant award, bringing the total grant award to a new total of five-million, one hundred forty-nine thousand, nine hundred and six dollars (\$5,149,906); and

WHEREAS, ONDCP further modified grant award #G13GA0003A with modification #3 which adds sixty thousand, five hundred dollars (\$60,500.00) to the grant award, bringing the total grant award to a new total of five-million, two hundred ten thousand, four hundred and six dollars (\$5,210,406.00); and

WHEREAS, the sum of modification #2 and modification #3 to grant award #G13GA0003A is fifty-one thousand, three hundred and forty-one dollars (\$51,341.00) added to the grant; and

WHEREAS, the Department wishes to accept the grant modifications to continue funding the Atlanta HIDTA task force.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:

SECTION 1: That the 2014 (Intergovernmental Grant Fund) Budget, Department of Police, is hereby amended as follows:

**WHEREAS**, the White House Office of National Drug Control Policy (“ONDCP”) grants funding to High Intensity Drug Trafficking Area (“HIDTA”) program task forces responsible for disrupting and dismantling violent drug trafficking organizations; and

**WHEREAS**, the Department of Police (“Department”) has been a participant in the Atlanta High Intensity Drug Trafficking Area task force (“Atlanta HIDTA”) for over ten years; and

**WHEREAS**, as per Resolution 05-R-0680, the Atlanta Police Department (“Department”) acts as the “pass through agency” to disburse payments for task force expenses that are completely federally funded, and with no matching funds; and

**WHEREAS**, the ONDCP has awarded the City grant G13GA0003A (“grant”), in the amount of two-million, five hundred thirty-three thousand, one hundred sixteen dollars (\$2,533,116), to continue funding the Atlanta HIDTA task force initiatives, and this award was approved by the City Council of Atlanta and the Mayor through ordinance 13-O-1034; and

**WHEREAS**, ONDCP modified grant award #G13GA0003A by adding modification #1 to the original grant award of an additional two million, six hundred twenty-five thousand, nine hundred forty-nine dollars (\$2,625,949) with no matching funds, bringing the grant award to a new total of five-million, one hundred fifty-nine thousand, sixty-five dollars (\$5,159,065) and this modification was approved by the City Council of Atlanta and the Mayor through 13-O-1176; and

**WHEREAS**, ONDCP further modified grant award #G13GA0003A with modification #2 which deducts nine thousand, one hundred fifty-nine dollars (-\$9,159) from the grant award, bringing the total grant award to a new total of five-million, one hundred forty-nine thousand, nine hundred and six dollars (\$5,149,906); and

**WHEREAS**, ONDCP further modified grant award #G13GA0003A with modification #3 which adds sixty thousand, five hundred dollars (\$60,500) to the grant award, bringing the total grant award to a new total of five-million, two hundred ten thousand, four hundred and six dollars (\$5,210,406); and

**WHEREAS**, the sum of modification #2 and modification #3 to grant award #G13GA0003A is fifty-one thousand, three hundred and forty-one dollars (\$51,341) added to the grant; and

**WHEREAS**, the Department wishes to accept the grant modifications to continue funding the Atlanta HIDTA task force.
