LEGISLATION HISTORY - BLUE BACK

AN ORDINANCE BY FINANCE/EXECUTIVE COMMITTEE TO AMEND ORDINANCE NUMBER 14-O-1067 TO INCLUDE THE TRANSFER TO APPROPRIATIONS FUNDING STREAM. THE ORDINANCE TRANSFERS FUNDS IN THE AMOUNT OF \$12,500.00 FROM THE POST 1 AT-LARGE COUNCILMEMBER CARRY FORWARD IN THE NON-DEPARTMENT RESERVES TO THE POST 1 AT-LARGE OPERATING EXPENSE ACCOUNT.

WHEREAS, the Post 1 At-Large Councilmember wishes to transfer funds to his expense account; and
WHEREAS, the funding stream for the transfer to appropriations was not included in Ordinance 14-O-1067; and

WHEREAS, the transfer is for continued operation of the Post 1 Council Office.

WHEREAS, this legislation will amend Ordinance 14-O-1067 that transfers \$12,500.00 to pOst 1 At-Large Operating Expense Account by including the transfer to appropriations funding stream.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY ORDAINS, as follows:

SECTION 1: That the 2014 (General Fund) Budget be and is hereby amended as follows:
