AN ORDINANCE BY COMMUNITY DEVELOPMENT/HUMAN RESOURCES COMMITTEE AMENDING THE 2014 (INTERGOVERNMENTAL GRANT FUND) BUDGET BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS TO THE CITY OF ATLANTA FROM THE NATIONAL RECREATION AND PARKS ASSOCIATION FOR THE PURPOSE OF SUPPORTING THE COCA-COLA TROOPS FOR FITNESS PROGRAMMING FUNDED BY THE NATIONAL RECREATION AND PARKS ASSOCIATION (“NRPA”) AND THE COCA-COLA FOUNDATION ON BEHALF OF THE DEPARTMENT OF PARKS AND RECREATION; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta’s (“City”) Department of Parks and Recreation (“DPR”) enhances the lives of residents offering programs, services and activities that encourage participation in safe, enriching activities, leisure activities and cultural experiences throughout Atlanta; and

WHEREAS, DPR’s, Office of Recreation has been awarded a grant from the National Recreation and Parks Association by the Coca-Cola Foundation in the amount of One Hundred Ninety Two Thousand Five Hundred Dollars and No Cents (\$192,500.00) over a three year period commencing in 2013 to fund the newly created Coca-Cola Troops for Fitness Program, which offers fitness camps and classes to community members of all ages with a priority on adults, along with employment opportunities for individuals of veteran status as fitness instructors (the “Program”); and

WHEREAS, the goals of the Program are to increase community participation in fitness programming and nutritional educational education activities and provide employment opportunities and the hiring of veterans to instruct fitness and nutrition programs; and

WHEREAS, the 2014 (Intergovernmental Grant Fund) Budget should be amended to anticipate the payments; and

WHEREAS, the City will benefit from this grant and is appreciative of the generosity of the National Recreation and Parks Association by the Coca-Cola Foundation.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:

SECTION 1: That the 2014 (Intergovernmental Grant Fund) Budget is amended to allow for payments in connection with the Coca-Cola Troops for Fitness Program with all funds to be deposited into:
