

WHEREAS, The Post I At-Large Council office has supported certain projects, events and other community based activities in the Atlanta community which are defined as charitable purposes as per O.C.G.A. 43-17-2 (3); and,

WHEREAS, It is the intent of the Post 1 At-Large Councilmember to make donations to various charitable organizations in the amount of One Thousand Nine Hundred and Eighty Dollars (\$1,875.00).

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1: That the Post 1 At-Large Councilmember is authorized to make contributions in an amount not to exceed One Thousand Nine Hundred and Eighty Dollars (\$1,875.00) for the purpose of funding charitable organizations.

SECTION 2: That the Chief Financial Officer is authorized to remit payment for the purposes referenced below upon receipt of proper invoice, to be paid as follows:

MAAC Atlanta Scholarship \$500.00

Villages of Carver Family YMCA \$1,000.00
