WHEREAS, the City of Atlanta has an interest in maintaining the public safety and welfare of citizens of the City of Atlanta and its visitors; and

WHEREAS, the City of Atlanta has an interest in regulating, through the lawful exercise of its police powers, the sale of alcoholic beverages and certain other types of businesses within its territorial limits; and

WHEREAS, traditionally the City of Atlanta has maintained provisions relating to the operation and licensing of "Bottle Houses" in Chapter 10 of the City of Atlanta Code of Ordinances (the Alcohol Code); and

WHEREAS, as a result of the proliferation of licenses for the sale of alcohol for consumption on the premises, the Bottle House license is now archaic and the existence of Bottle House regulations has contributed to confusion throughout the community; and

WHEREAS, it is the opinion of the Atlanta City Council that there is no longer any need to maintain any Bottle House regulations in the Alcohol Code; and

WHEREAS, it is the desire of the Atlanta City Council that the Alcohol Code be amended to strike all references to Bottle House licenses; and

WHEREAS, it is the desire of the Atlanta City Council that the Alcohol Code be amended to specify that a license for consumption of alcohol on the premises shall allow patrons to bring alcohol on to the premises for consumption thereon; and

WHEREAS, it is the desire of the Atlanta City Council that the Alcohol Code be amended to specify that holders of licenses for off/premises consumption shall not be permitted to allow

their patrons to bring alcohol on to the premises for consumption thereon.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY ORDAINS, as follows:
