AN ORDINANCE BY COMMUNITY DEVELOPMENT/HUMAN RESOURCES COMMITTEE AUTHORIZING THE MAYOR OR HIS DESIGNEE, ON BEHALF OF THE CITY OF ATLANTA, TO AUTHORIZE THE ACCEPTANCE OF A GRANT IN THE AMOUNT OF THIRTY TWO THOUSAND FORTY ONE DOLLARS AND SIXTY-THREE CENTS (\$32,041.63) FROM THE DEKALB WORKFORCE DEVELOPMENT AGENCY AS THE FISCAL AGENT AS PART OF A U.S. DEPARTMENT OF LABOR WORKFORCE INNOVATION FUND GRANT; BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF THIRTY-TWO THOUSAND FORTY-ONE DOLLARS AND SIXTY-THREE CENTS (\$32,041.63) FOR PURPOSES TO EXPAND AND IMPROVE EDUCATION, TRAINING, AND EMPLOYMENT OPPORTUNITIES AND BARRIER REMOVAL FOR THE LONG-TERM UNEMPLOYED, AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta (“City”) administers special programs under contract to the Atlanta Workforce Development Agency (“AWDA”); and

WHEREAS, DeKalb Workforce Development (“DWD”) acting as the local area fiscal agent of a Consortium initiative in accordance of a U.S. Department of Labor funded Workforce Innovations Fund grant; and

WHEREAS, the Consortium initiative is designed to expand and improve education, training, and employment barriers of the long-term unemployed individuals; and

WHEREAS, DWD is the Consortium grant recipient; and

WHEREAS, AWDA was awarded Thirty-Two Thousand Forty-One dollars and Sixty-Three Cents (\$32,041.63) in grant funds under the Workforce Innovation Fund (“WIF”); and

WHEREAS, AWDA recommends the City to accept the USDOL Grant to support its initiative to expand and improve education, training, and employment opportunities for the long-term unemployed individuals with funding; and

WHEREAS, AWDA recommends amending the (Job Training Grant Fund) budget, increasing the receipts by adding to anticipations and appropriations in the amount of Thirty-Two Thousand Forty-One dollars and Sixty-Three Cents (\$32,041.63).

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Section 1: The Mayor or his designee, on behalf of the City of Atlanta, is authorized to accept a USDOL grant in the amount of Thirty-Two Thousand Forty-One dollars and Sixty-Three Cents (\$32,041.63) for the purpose of expanding and improving education, training, and employment opportunities for the long-

term unemployed individuals; and

Section 2: That such documents as may be necessary be authorized to be executed by appropriate parties to effectuate said grant; and

Section 3: That the (Job Training Grant Fund) budget is hereby amended as follows:

Section 4: That the FY2014 (Job Training Grant Fund) budget is hereby amended as follows:
