THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY ORDAINS:

SECTION 1. The Land Use element of the 2011 Atlanta Comprehensive Development Plan (CDP) to redesignate properties that are located at 455 Fourteenth Street from the Industrial and the Low Density Commercial land use Designation to the Very High Density Residential land use designation and for other purposes (Z-14-11) designation to wit:

All that tract or parcels of land lying and being in Land Lot 148 and 149 of the 17th of Fulton County, Georgia. Said property is more specifically shown on the attached map, Exhibit 'A', which is hereby made a part of this ordinance.

SECTION 2. That all ordinances or parts of ordinances which are in conflict with this ordinance are hereby repealed.
