THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY ORDAINS:

SECTION 1. The Land Use element of the 2011 Atlanta Comprehensive Development Plan (CDP) to redesignate property that are located at 1131,1137 Glenwood Avenue and 1146, 1152 Portland Avenue from the Low Density Residential land use designation to the Low Density Commercial land use designation and for other purposes (Z-14-17) designation to wit:

All that tract or parcels of land lying and being in Land Lot 32 of the 14th of Fulton County, Georgia. Said property is more specifically shown on the attached map, Exhibit 'A', which is hereby made a part of this ordinance.

SECTION 2. That all ordinances or parts of ordinances which are in conflict with this ordinance are hereby repealed.


