

**AN ORDINANCE BY COUNCILMEMBER CARLA SMITH AUTHORIZING THE MAYOR OR HIS DESIGNEE TO MAKE MARTIN STREET, S.E. A MULTI-WAY STOP WHERE IT INTERSECTS WITH HAYGOOD AVENUE, S.E.; AND FOR OTHER PURPOSES.**

Whereas, residents of the neighborhood in the area surrounding Martin Street, SE at Haygood Avenue SE have expressed their concerns regarding the high volume of vehicles that come through that intersection due, in large measure, to D.H. Stanton Park and Boynton Village Apartments traffic; and

Whereas, there are many families in the area in which households run the gamut of senior citizens to elementary age children; and

Whereas, there is an ongoing concern with respect to public safety for both vehicles and pedestrians at Martin Street, S.E. where it intersects with Haygood Avenue SE

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS:**

SECTION 1: That the Mayor or his designee is authorized to make the intersection at Martin Street, SE where it intersects with Haygood Avenue SE, a multi-way stop with stop signs to be installed at the appropriate approaches to the intersection.

SECTION 2: That all ordinances and parts of ordinances in conflict herewith be and the same are hereby repealed
