WHEREAS, due to the concern and support of the community both in the Metropolitan Atlanta area, the State of Georgia, as well as outside the State of Georgia funds were contributed to the City of Atlanta to help defray some of the cost of the investigation, and

WHEREAS, it has been over thirty years since this investigation took place and there is still a balance of One Hundred Thirty Eight Thousand Twenty Nine Dollars and Seventy Seven Cents (\$138,029.77) in donations collected remaining in the City's Trust Fund, and

WHEREAS, ordinance 14-0-1195 was adopted as amended by the Atlanta City Council on June 16, 2014 and approved by operation of law on June 25, 2014 to repurpose these residual funds failed to cite the accounting strings to receive repurposed Trust Fund balances from the Murdered and Missing Children Fund, and

WHEREAS, ordinance 14-0-1195 as amended designated that Fifteen Thousand Dollars (\$15,000.00) be directed to the Atlanta Victim Witness Program and Fifteen Thousand Dollars (\$15,000.00) be contributed to the United Youth Adult Conference in support of its efforts in improving the quality of life for youth, young adults and senior citizens in the Atlanta community, with the remaining \$108,029.77 to be directed to the Police Athletic League in support of the Police Department's efforts with the youth of Atlanta.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:
