WHEREAS, the Atlanta Police Department (“Department”) has determined a need to equip police vehicles with mobile data terminals and their modems and other related hardware and software to provide Atlanta Police officers with vital information while on patrol; and

WHEREAS, pursuant to the City’s Procurement and Real Estate Code of Ordinances 2-1602, the Chief Procurement Officer may procure supplies, services and construction items through contracts established by public procurement units where such contracts and contractors substantially meet the requirements of the city’s Procurement and Real Estate Code; and

WHEREAS, The United States General Services Administration (“GSA”) contract #GS-35F-0186P with Computech International was competitively procured in a manner consistent with Division 4 of the City’s Procurement and Real Estate Code, and the costs of the goods and/or services are comparable; and

WHEREAS, Watchguard is listed as an authorized reseller for Computech International in the body of the GSA contract #GS-35F-0186P; and

WHEREAS, the Chief of Police and the Chief Procurement Officer recommend entering into a cooperative purchasing agreement with Watchguard, as an authorized reseller of Computech International, designated by the Department of Procurement as COA-7348-PL, utilizing GSA contract #GS-35F-0186P with Computech International, for the purchase and installation of mobile data terminals and their modems and other related hardware and software in police vehicles, on behalf of the Atlanta Police Department; and other purposes; and

WHEREAS, the Department has identified as the funding source for the purchase and installation of the mobile data terminals and their modems and related hardware and software in police vehicles the amount of three hundred fifty-one thousand, fifty dollars (\$351,050) from 3503 (CAPITAL FINANCE FUND); 240201 (APD POLICE ADMINISTRATION); 5421003 (EQUIPMENT \$5,000+); 3210000 (POLICE ADMINISTRATION); 000000 (DEFAULT); 00000 (DEFAULT).

THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES that the Mayor be and is hereby authorized, pursuant to 2-1602 of the City of Atlanta Code of Ordinances, to enter into a cooperative purchasing agreement with Watchguard, as an authorized reseller of Computech International, designated by the Department of Procurement as COA-7348-PL, utilizing the United States General Services Administration (“GSA”) contract #GS-35F-0186P, for the purchase and installation of mobile data terminals and their modems and other related hardware and software in police vehicles, on behalf of the Atlanta Police Department, in an amount not to exceed three hundred fifty-one thousand, fifty dollars (\$351,050).

BE IT FINALLY RESOLVED, that the purchase order will not become binding upon the City and the City shall incur no obligation or liability until it has been approved by the Chief Procurement Officer.
