WHEREAS, KIMBERLYN SHAW-MALLORY V. CITY OF ATLANTA, is a lawsuit in which Plaintiff sought to recover damages from the City of Atlanta resulting from alleged negligent actions by a City of Atlanta employee; and

WHEREAS, Plaintiff alleges the City of Atlanta employee was negligent in the use of a motor vehicle and that this alleged negligence caused Plaintiff's bodily injuries; and

WHEREAS, Plaintiff has agreed to accept the Settlement Amount in full settlement of all claims against the City of Atlanta; and

WHEREAS, the City Attorney has done extensive review of the facts and the law and has determined that the City's potential financial exposure in defending Plaintiff's claim is in excess of the Settlement Amount; and

WHEREAS, the City Attorney considers it to be in the best interest of the City to pay the Settlement Amount to settle all claims against the City of Atlanta.

THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY RESOLVES as follows:

SECTION 1. The City Attorney is hereby authorized to settle and execute all documents in the case of KIMBERLYN SHAW-MALLORY V. CITY OF ATLANTA in the amount of Thirty-Eight Thousand Dollars (\$38,000.00).

SECTION 2. The Chief Financial Officer is authorized to make payment from FUND 1001 (GENERAL FUND), CENTER NUMBER 200101 (NON-DEPARTMENTAL), ACCOUNT 5212005 (LITIGATION EXPENSES) and FUNCTIONAL ACTIVITY NUMBER 1512000 (ACCOUNTING). Payment shall be in the form of a check in the amount of \$38,000.00 payable to Kevin Ford and his client, Kimberlyn Shaw, P.O. Box 550229, Atlanta, GA 30355. Such payment shall be in full consideration of the dismissal of all claims against the City of Atlanta and its current and former officers and employees.
