A RESOLUTION BY COMMUNITY DEVELOPMENT/HUMAN RESOURCES COMMITTEE AUTHORIZING THE MAYOR TO ENTER INTO A RENEWAL TO THE MEMORANDUM OF UNDERSTANDING BETWEEN THE BOYS AND GIRLS CLUB OF METRO ATLANTA AND THE CITY OF ATLANTA; AND FOR OTHER PURPOSES.

WHEREAS, the Boys and Girls Club of Metro Atlanta (“BGCMA”) is a Georgia non-profit corporation dedicated to providing quality community programs to metro Atlanta children; and

WHEREAS, the City of Atlanta (“City”) owns and operates the Recreation Centers throughout Atlanta (the “Centers”) where it is committed to providing high quality programming for its metro Atlanta youth; and

WHEREAS, the City and BGCMA (collectively the “Parties”) entered into an Memorandum of Understanding (“MOU”) as authorized by 13-R-3276, adopted by the City Council on July 1, 2013 and approved as per City Charter Section 2-403 on July 10, 2013 whereby BGCMA provides afterschool and weekend programming at the Adamsville, Ben Hill, Pittman, and Thomasville Recreation Centers at no cost to the City; and

WHEREAS, the initial term of the MOU was for one (1) year with two (2) one (1) year renewal options by mutual consent of the parties; and

WHEREAS, the initial term is set to expire July 31, 2014; and

WHEREAS, the BGCMA has successfully provided afterschool and weekend programming at the aforementioned Centers at no cost to the City and has offered to extend its services to Adams Park as well; and Centers; and

WHEREAS, BGCMA and the City desire to continue their partnership providing after-school and weekend programs of recreational, educational, and cultural activities for children at the Centers, with BGCMA serving as a vendor of the City’s programs at no cost to the City; and

WHEREAS, the Commissioner of Parks and Recreation has reviewed and is satisfied with the BGCMA’s performance under the MOU and desires that the MOU be extended for one year.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Mayor or his designee, on behalf of the City, is hereby authorized to enter into a

renewal to the Memorandum of Understanding (“MOU”) between the City and BGCMA under which BGCMA shall continue to provide operation, maintenance, and programming at the Centers at no cost to the City.

BE IT FURTHER RESOLVED, that the City Attorney, or his designee is hereby authorized to prepare the MOU for execution by the Mayor.

AND FINALLY BE IT RESOLVED, that the renewal shall not become binding on the City, and the City shall incur no obligation or liability under it until it has been executed by the Mayor, attested to by the Municipal Clerk, approved as to form by the City Attorney, and delivered to BGCMA.
