Expansion of Preparing Adult Offenders to Transition through Training and Therapy (PAT³) Georgia Department of Corrections Partnership

- House an additional 200 transition center-eligible state inmates from the Georgia Department of Corrections (150 males, 50 females)
- 20 males are scheduled to arrive at ACDC on 09/27/18
- Expand PAT³ partnership with Department of Public Works (DPW) to include a four-week commercial driver's license (CDL) certification to act as a force multiplier positioning DPW to deploy more trucks on the streets









Atlanta City Detention Center Average Daily Population and Jail Reform Initiatives Timeline

Average Daily Population	Jail Reform Initiatives
February 22 – 28, 2018: 439	March 2018: ACDC went live with the City's ordinance to eliminate cash bonds replacing in lieu of signature bonds for eligible detainees
June 15 – 21, 2018: 374	June 2018: Mayor Bottoms signed an executive order prohibiting ACDC from housing new ICE detainees
July 1 – 31, 2018: 249	July 2018: Atlanta City Council ratified the mayor's executive order prohibiting housing of ICE detainees until further notice

Atlanta City Detention Center Critical Repairs and Enhancements (COMPLETED)

Energy Conservation Measures

- Interior lighting and lighting controls
- Domestic water conservation
- Cooling tower water metering and sewer credit
- Chiller replacement
- Inlet guide vane to VFD conversion
- Retrofit AHUs 1 and 2 with fan array units
- Kitchen hood controls
- Emergency Roof Repair (Phase 1)
- Upgrade Fire Alarm and Suppression Services (Phase 1)
- Security System Upgrades and System Integration (Phase 1)
- Modernization of Elevators 2, 3, 4 & 5
- Upgrade Sally Port Door Controls for Movement



Atlanta City Detention Center Critical Repairs and Enhancements (PENDING - Funded)

- Replace 23 year old roof to alleviate current water intrusion issues caused by natural aging of roof - \$3,000,000
- Phase I of camera upgrades and expansion of the Genetec Management System to include video storage, switches, ON Cam cameras and IP cameras - \$298,377
- Rebuild 8th floor officer's stations and intake officers desk -\$150,000
- Upgrade fire alarm and fire suppression network system to address issues with existing field initiation devices. (Phase II: smoke detectors, heat detectors - \$200,000)
- Replace grease trap and drains in dish room \$5,000



Atlanta City Detention Center Critical Repairs and Enhancements (PENDING - Unfunded)

- Upgrade network fiber optics to support electronic security system upgrades, integration of the new Gentec system into current APD Operation Shields' Program and additional AP's within the facility to optimize Wi-Fi coverage \$446,500
- Assess concrete expansion joints \$850,000
 Note: Actual cost for needed adjustments not included
- Modernize of elevators 1 and 6 (Visitation Elevators) \$550,000
- Update heating and air system controls from pneumatic to electronic controls (including repairs need to close out various energy efficiency projects)
 \$1,500,000
- Replace shower tiles in housing units and repairs to employee locker rooms -\$581,917
- Update door controls from pneumatic to electronic \$200,000
- Sally port door replacement \$175,000

18-0-1045: Elimination of Cash Bond

Sec. 62-31 (a) Directs Chief of Corrections, or designee, to "release on own recognizance or signature"... "immediately after booking"

Section 9: That the Chief of Corrections shall be tasked with monitoring the results of implementing this ordinance, and shall provide a presentation regarding the results to the Public Safety Committee of the Atlanta City Council six month after implementation. The presentation shall be open for public attendance.
