The Public Safety and Legal Administration of the Atlanta City Council will hold a Public Hearing in Committee Room 1, City Hall, 55 Trinity Avenue, S.W., 2nd Floor on the following proposed legislation:

- 16-O-1149 AN ORDINANCE BY THE PUBLIC SAFETY AND LEGAL ADMINISTRATION COMMITTEE TO AMEND CHAPTER 122, (SECONDHAND GOODS), ARTICLE III, (PAWNBROKERS), AND ARTICLE IV, (PRECIOUS METALS DEALERS), TO UPDATE THE REGULATIONS SUCH BUSINESSES SHALL BE SUBJECT TO DUE TO CHANGES IN TECHNOLOGY, AND IN THE INTEREST OF PUBLIC SAFETY AND UNIFORMITY; TO REQUIRE SUCH BUSINESSES TO REPORT THEIR TRANSACTIONS ELECTRONICALLY; TO UPDATE THE REGULATORY FEES ASSOCIATED THEREWITH; AND FOR OTHER PURPOSES.**
- 16-O-1150 AN ORDINANCE BY THE PUBLIC SAFETY AND LEGAL ADMINISTRATION COMMITTEE AMENDING CHAPTER 10, ARTICLE II, DIVISION 5, SECTION 10-206 AND CHAPTER 30, ARTICLE II, SECTION 30-28, OF THE CODE OF ORDINANCES OF THE CITY OF ATLANTA, GEORGIA, FOR THE PURPOSE OF ADJUSTING THE ANNUAL PERMIT FEE REQUIRED FOR EMPLOYEES AT ADULT ENTERTAINMENT ESTABLISHMENTS SELLING ALCOHOLIC BEVERAGES; TO REQUIRE THE PAYMENT FEES ANNUALLY UPON RENEWAL OF SUCH PERMITS; AND FOR OTHER PURPOSES.**
- 16-O-1135 AN ORDINANCE BY COUNCILMEMBER YOLANDA ADREAN TO AMEND CHAPTER 10, ARTICLE II, DIVISION 2, SUBDIVISION II, SECTION 10-87 OF THE CITY OF ATLANTA CODE OF ORDINANCES, TO PROHIBIT THE ISSUANCE OF A LICENSE TO SELL ALCOHOLIC BEVERAGES WITHIN THE CITY OF ATLANTA FOR ANY LOCATION PERMITTED BY THE CITY AS A SHOOTING GALLERY; AND FOR OTHER PURPOSES.**
