A RESOLUTION BY COUNCILMEMBER ALEX WAN: A RESOLUTION SUPPLEMENTING THAT BOND FINANCING ORDINANCE 16-O-1105 ADOPTED BY THE CITY COUNCIL (THE "CITY COUNCIL") OF THE CITY OF ATLANTA, GEORGIA (THE "CITY") ON MARCH 21, 2016 AND APPROVED BY THE MAYOR ON MARCH 21, 2011 TO, AMONG OTHER THINGS, PROVIDE FOR THE ISSUANCE AND SALE BY THE CITY OF ITS TAX ALLOCATION REFUNDING BONDS (EASTSIDE PROJECT), SERIES 2016, IN AN AMOUNT NOT TO EXCEED THIRTY-EIGHT MILLION DOLLARS \$38,000,000 (THE "SERIES 2016 BONDS"), WITHIN CERTAIN PARAMETERS ESTABLISHED BY THE CITY, INCLUDING THE ORIGINAL AGGREGATE PRINCIPAL AMOUNT, INTEREST RATES, MATURITY DATES AND MAXIMUM AGGREGATE ANNUAL DEBT SERVICE, WITH RESPECT THERETO; APPROVE AND CONFIRM CERTAIN ACTIONS OF THE CITY COUNCIL AND CERTAIN OFFICERS AND AGENTS OF THE CITY WITH RESPECT TO THE ISSUANCE AND SALE OF THE SERIES 2016 BONDS; TO PROVIDE FOR THE PAYMENT, IN FULL, OF CERTAIN OUTSTANDING TAX ALLOCATION BONDS PREVIOUSLY ISSUED TO PAY REDEVELOPMENT COSTS ASSOCIATED WITH THE PROJECTS WITHIN THE EASTSIDE TAX ALLOCATION DISTRICT; TO AUTHORIZE PAYING EXPENSES INCIDENT TO ACCOMPLISHING THE FOREGOING; TO AUTHORIZE THE EXECUTION OF A SECOND SUPPLEMENTAL INDENTURE OF TRUST; TO APPROVE THE FORM OF THE BOND PURCHASE AGREEMENT AND TO AUTHORIZE THE EXECUTION THEREOF; AND APPROVING THE USE AND DISTRIBUTION OF A PRELIMINARY OFFICIAL STATEMENT AND FINAL OFFICIAL STATEMENT; AND FOR OTHER PURPOSES.
