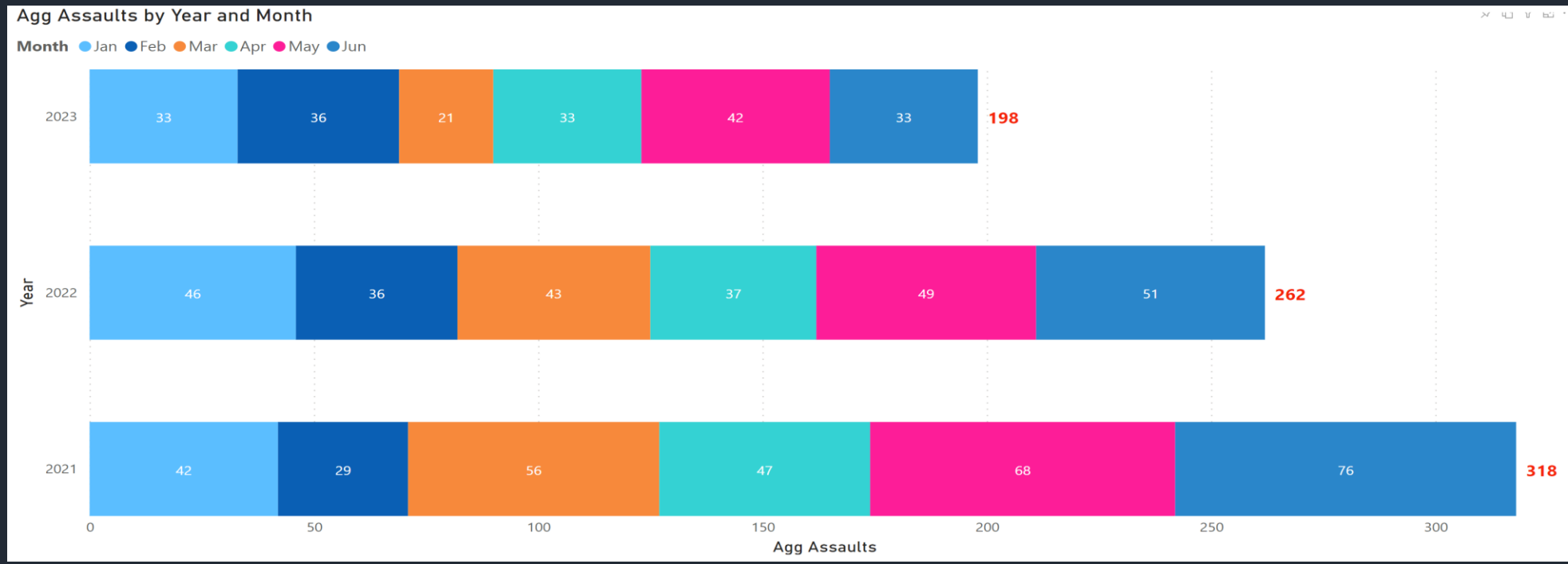

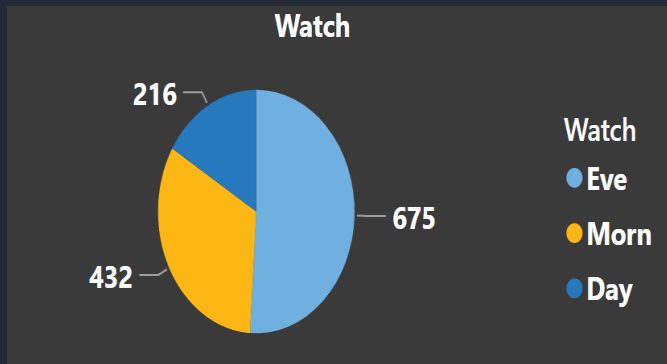

Kia/Hyundai Auto Theft Week 22: 2023 vs. 2022

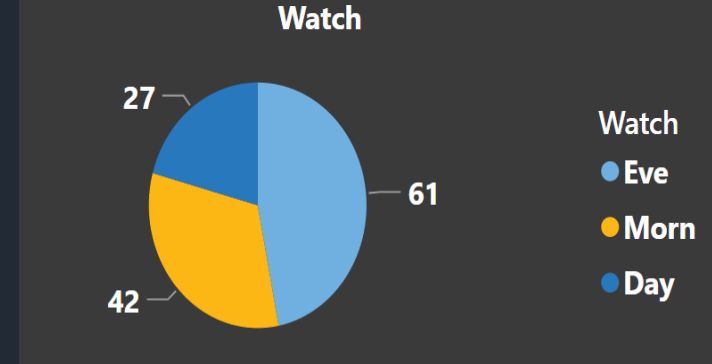

2 Arrested – 2 different vehicles – same parking lot

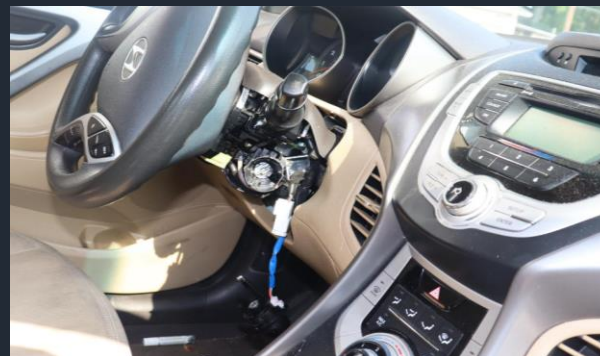
- Off-Duty officers noticed a stolen Kia with several suspects

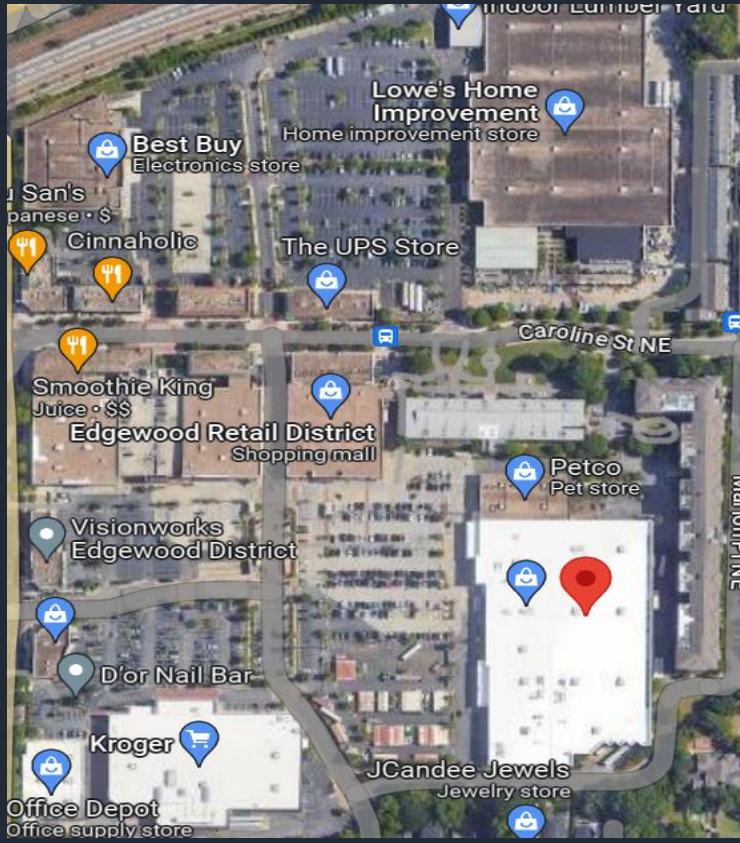
