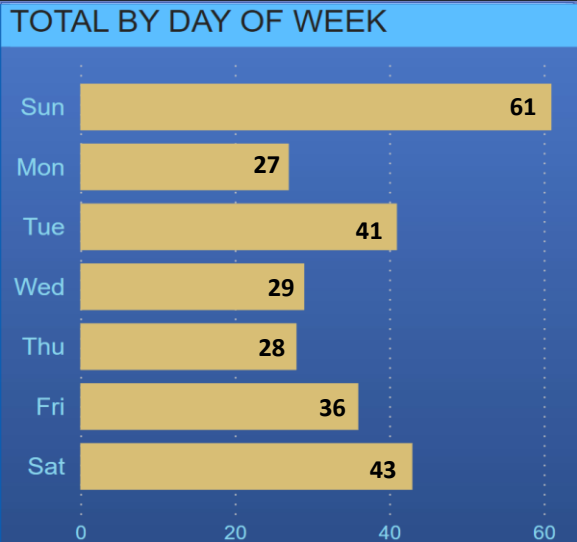
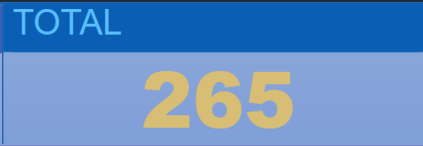

### Aggravated Assault – Person Shot Incidents thru Week 33

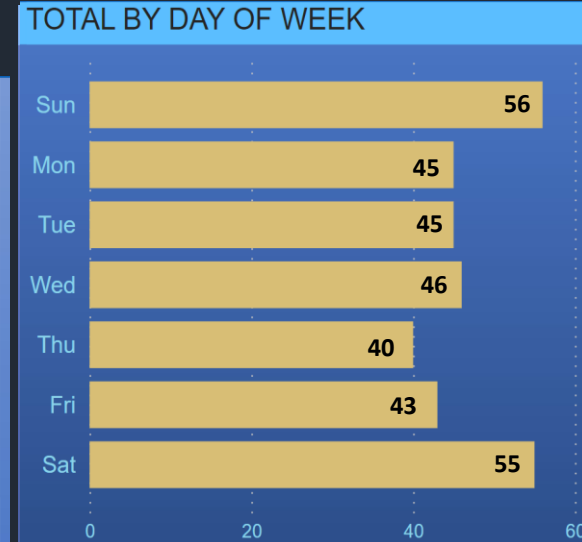
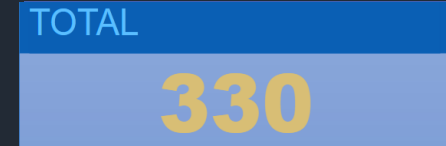

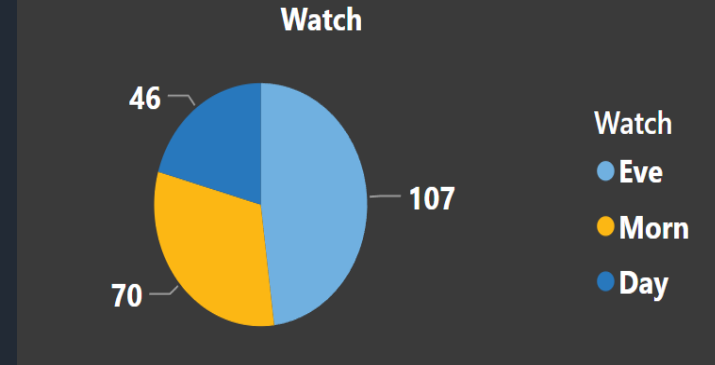
