# 2023 CASE INVESTIGATION SUMMARY

Epidemiologists routinely conducts investigations into reported notifiable diseases to determine if they meet case definition criteria and then conduct public health follow-up.

The following numbers reflect the number of suspect cases reported per disease category. In some instances, investigation determined they were not confirmed cases.



# SITUATIONAL UPDATE Expiration of the Public Health Emergency Declaration



#### BACKROUND

- On January 31, 2020, the U.S. Department of Health and Human Services (HHS) declared a U.S. public health emergency because of the emergence of a novel virus, SARS-CoV-2.
- After 13 renewals, the public health emergency expired on May 11, 2023.
- An MMWR was released by CDC outlining implications: <u>COVID-19 Surveillance After</u> <u>Expiration of the Public Health Emergency</u> <u>Declaration — United States, May 11, 2023</u>



# COVID-19 REPORTING POST-PHE

- Authorizations to collect certain public health data expired at the end of the U.S. public health emergency declaration on May 11, 2023.
- At this time, COVID-19 will remain reportable both nationally and in Georgia beyond the PHE.
- Reporting of negative SARS-CoV-2 testing results will no longer be required.



#### **IMPLICATIONS**

- Due to discontinuation of negative result reporting, several data elements from the FCBOH COVID-19 weekly report will no longer be available. These changes include, but are not limited to:
  - % Positivity
  - Community Transmission Level
- After May 11, 2023 these changes will be reflected in any reports produced by FCBOH Epidemiology.
  - The COVID report will be published once a month






#### COVID-19 YEARLY TRENDS COMPARISON IN FULTON COUNTY

#### **GA COVID-19 TRENDS: DEATHS**




### Influenza Update



#### **INFLUENZA**

 The Influenza-like Illness (ILI) intensity indicator for Georgia during Week 43 was moderate = 6, on a scale of 1 - 13. As of the start of the season, we have had 40 influenza hospitalizations in the metro-Atlanta area, 3 reported influenza outbreaks, and 0 confirmed influenzaassociated deaths.

- Solidified partnerships and response plans






### Vista Forge Exercise

A radiological disaster response training exercise designed to evaluate response efforts to radiological disasters or emergencies within Metro Atlanta held in November 2022.

Decontamination of both **humans** and **animals** was a unique focus.

EPI and Emergency Preparedness worked alongside other agencies (AFCEMA, American Red Cross, and Georgia State University) to coordinate the establishment of the Family Assistance Center which was dedicated to the **reunification** of family members and pets and a place to connect affected individuals with necessary **resources**.





# Vista Forge Exercise, Continued

#### Members of the Epi team:

- Collaborated with other coordinating agencies to design the layout of the FAC & identified spaces for partnering organizations
- Assisted Emergency
   Preparedness with testing their portal monitor, a radioactive detection device
- Conducted patient intake to identify patients' needs and assisted with reunification; entered information into WebEOC
- Relayed important information between the FAC and Unified Command and vice versa
- Connected patients with necessary resources after the intake process was completed

# **Environmental Health Mosquito control**

Environmental Health mosquito control program has been active in Fulton County since 2001 and is an important component to prevent the spread of vector-borne illnesses such as West Nile Virus (WNV) and the Zika virus.

To combat the spread of vector-borne illnesses

- Mosquito control program provides:
  - Surveillance and testing of multiple sites around Fulton County
  - Larviciding, and adulticiding (Spraying)
  - Public education and prevention awareness.

**Mosquito season: July- October** 





# **Environmental Health Rodent control**

- Controlling rats by eliminating conditions conducive to were breeding and living is possible.
- Rat control includes inspection of property, sanitation, elimination of harborage, and distribution of rat poison to qualified, Fulton County homeowners




