




Contracts Team Metrics as of Q2




















Watershed Team Metrics as of Q2

October 1 – December 31, 2023






Litigation Division

Between October 1 – December 31, 2023, the Litigation Division was served with 127 Quiet Title and Interpleader petitions. In response, the City filed 194 claims for payment totaling \$1,054,471.

During this time-period, the City collected \$350,524 in payment of delinquent ad valorem taxes, delinquent solid waste bills, delinquent water bills and unpaid demolition lien costs.

Q2 Pending Claims

• The Department of Law maintained 1,147 pending claims from October 1, 2023, to December 31, 2023.

Q2 New Claims

• The Department of Law received 345 new claims from October 1, 2023, to December 31, 2023, an average of 115 new claims per month.

Q2 Resolved Claims

• The Claims Team has resolved 261 claims during the past quarter, an average of 86 claims per month.

DIVISION METRICS: UPDATE ON SETTLEMENTS AND CLAIMS – Q2

- The Department of Law has successfully and effectively litigated case settlements in FY24 Q2 that resulted in the City only paying \$841,750 when the demand amount was \$2,859,051.
- The Department of Law has successfully and effectively negotiated claim settlements in FY24 Q2 that resulted in the City only paying \$458,290 when the demand amount was \$1,336,598.

■ There is currently an increase overall of 19% in FY24 July - Feb. 2024 outside counsel spending compared to FY23 July - Feb. 2023. In terms of the Enterprise Funds, there is an increase of 32% in Aviation Fund outside counsel spending due to Litigation and General Airport matters, an increase of 34% in Watershed Fund outside counsel spending due to EPA SEP Stipulated Penalty Demand Litigation and Environmental Advice matters. In terms of the General Fund, there is currently an increase of 15% in General Fund outside counsel spending compared to FY23 July – Feb. 2023 due to the various Litigation matters and the Referendum.

BUSINESS SERVICES DIVISION HIGHLIGHTS

Division Highlights: Business Services – Contracts

The Department of Law's Contracts Team handled a number of legislative, procurement, and contract matters during Q2 including the following highlighted matters:



Airport Passenger Wait Time Reporting System

The Contracts Team negotiated and finalized a key technology services agreement on behalf of the Department of Aviation for operation and maintenance of the Airport's passenger wait time reporting system. The system provides real time passenger flow data and information to balance the Domestic and International Security Checkpoint queuing and provides passengers with accurate and timely wait time information.

Municipal Court Utility Project

The Contracts Team finalized a construction contract with Georgia Power on behalf of the Department of Enterprise Asset Management to change the power feed to the Municipal Court from an overhead to an underground grid system. The Court has experienced numerous power outages resulting in untimely disruption of key City services, leading to canceled court hearings, disruption of safety scanning equipment, and disruption of on-site ticket payments. This critical upgrade will provide protection against the interruption of services and protect the Court's safety operation functions.


Division Highlights: Business Services – Contracts

Interactive Voice Response System

On behalf of the Department of City Planning (DCP), the Contracts Team successfully completed protracted negotiations with Selectron Technologies to enter into a five-year agreement for continued implementation and development of an interactive voice response system. The system will allow citizens to streamline interactions with DCP, including allowing them to schedule permit inspections 24/7, 365 days per year.

Landfill Transfer Services

On behalf of the Atlanta Department of Transportation, the Contracts Team completed negotiations with Waste Management to enter into a critical agreement for the disposal of a multi-year backlog of construction debris associated with the construction and repair of the Department's infrastructure.



Legislation for the Department of Grants and Community Development

The Contracts Team assisted the Department of Grants and Community Development with drafting legislation to enter into an Intergovernmental Agreement with the City of Atlanta Housing Authority, the Georgia Historic Preservation Office, and IQ Simpson Affordable Housing, LP, to set forth the terms and conditions upon which construction and preservation projects are performed, and to mitigate adverse effects on historic properties as it relates to the new construction of a multi-story apartment building on Pollard Avenue.

Division Highlights: Business Services – Contracts

Tennis Center Management Services

On behalf of the Department of Parks and Recreation, the Contracts Team drafted, negotiated and finalized the five-year agreement with Agape Tennis Academy to operate and manage the five City-owned tennis centers. The tennis centers are valuable and beloved resources for the residents of the City, and the contract is expected to bring the City over \$1,500,000 in net revenue over the contract term.





City-Wide Compensation Study

On behalf of the Atlanta Police Department and Atlanta Fire and Rescue Department, the Contracts Team drafted an important amendment to the City's agreement with Mercer US to conduct a compensation and classification study of all sworn police and fire personnel, which will help the City to recruit and retain talented employees to provide quality services. The amendment further expanded the scope of the agreement to include additional peer agencies to account for changes in the competitive landscape.

The Department of Law's Real Estate/Land Use Team had the following notable highlights:

123 and 145 Dearborn Street Assemblage (Kirkwood Urban Forest Preserve)

The Real Estate and Land Use Team handled the closing on the acquisition of two parcels of property located at 123 and 145 Dearborn Street totaling 1.89 acres on behalf of the Department of Parks and Recreation. The property will be included as an addition to the City of Atlanta's existing Kirkwood Urban Forest Nature Preserve. The additional property will provide improved access, and more parkland and greenspace acreage in Southeast Atlanta.

Confederate (United) Avenue Combined Sewer Overflow Regulator Property Disposition

The Real Estate and Land Use Team handled the disposition of five parcels of property owned by the City known as the Confederate (United) Avenue CSO Regulator and Stockade Basin Stormwater Outfall (CSO). The Department of Watershed Management decommissioned the CSO, the property was declared as surplus property by the City, and a buyer was selected per a sealed bid process. The Real Estate and Land Use Team facilitated the closing and conveyance of the parcels to the buyer.

Utoy Creek Property Acquisition

The Real Estate and Land Use Team handled the closing on the acquisition of 27.56 acres of property located along Benjamin E. Mays Drive abutting Utoy Creek on behalf of the Department of Parks and Recreation. The acquisition of this property will protect and conserve high-value mature forested habitat for the benefit of the environment in perpetuity. Also, the property will be used for passive recreational activities with minimal environmental impact, conserve the ecosystem of the Utoy Creek water basin, and provide additional greenspace area for the residents of Southwest Atlanta.



North Fork Storage Facility Legislation

The Real Estate and Land Use Team worked with the Department of Watershed Management (DWM) to prepare legislation authorizing a long-term lease agreement with the Georgia Department of Transportation (GDOT). The lease at issue involves approximately three acres of GDOT property where DWM will install and maintain a wastewater storage and tank pump station to capture runoff from major storm events. In furtherance of the lease agreement, the Real Estate and Land Use Team assisted DWM with preparing legislation to abandon a portion of an undeveloped right of way on the same GDOT property, for the City of Atlanta to convey to GDOT.



Abandonment of a Portion of Right of Way Located at 1745 Westhaven Drive

The Real Estate and Land Use Team handled the abandonment of a portion of public right-of-way located adjacent to the intersection of Westhaven Drive and Rosemary Avenue. The right-of-way area was no longer being used by the City and was declared no longer useful or necessary for the public's use or convenience as a public right-of-way. The Real Estate and Land Use Team worked with the Departments of Transportation and Enterprise Asset Management to facilitate the drafting of legislation and conveyance of the property to the abandonment petitioner.



Abandonment of a Portion of Old Jonesboro Road

The Real Estate and Land Use Team handled the abandonment of a portion of a public street known as Old Jonesboro Road on behalf of the Department of Transportation (ATLDOT). This portion of the street was no longer in use by the City and was declared no longer useful or necessary for the public's use and convenience as a public right-of-way. The Real Estate and Land Use Team worked with ATLDOT to draft legislation to approve the abandonment, and with the Department of Enterprise Asset Management to facilitate the conveyance of the property to the abandonment petitioner/purchaser of the property.

Community Partnerships Memorandum of Understanding (MOU) for Programming and Recreational Services

The Real Estate and Land Use Team developed a form of MOU to standardize the terms and conditions of agreements for programming and recreational services provided by community organizations to the City of Atlanta in partnership with the Department of Parks and Recreation. The new form MOU provides consistent application of the City's policies and effective management of long-standing community partnership arrangements, which will ultimately streamline the process to engage additional organizations to provide programming and recreational services.



The Department of Law's Municipal Governance Team made the following notable contributions:

EXECUTIVE OFFICE

Fulton County & City of Atlanta Intergovernmental Agreement Supporting Center for Diversion Services

The Municipal Governance Team drafted new authorizing legislation and the Intergovernmental Agreement between the City and Fulton County to continue joint funding and support the Center for Diversion Services for a five-year term commencing January 1, 2024, and ending December 31, 2027. The prior Intergovernmental Agreement between the parties was for an initial 2-year term from January 22, 2022, ending December 31, 2023.

Memorandum of Understanding with Partners for HOME Supporting Rapid Housing Initiative

The Municipal Governance Team drafted a Memorandum of Understanding between Partners for HOME and City of Atlanta for the immediate allocation of \$4M to Partners for HOME for the purpose of acquiring the manufactured structures, transport, retrofit, and install at the City-owned property as a part of the Mayor's Rapid Housing Program.

EXECUTIVE OFFICE (cont.)

Operation HOPE, Inc. Legislation

The Municipal Governance Team drafted legislation to authorize the City to donate \$2M to Operation HOPE, Inc. to support financial literacy and entrepreneurial education for 300 City of Atlanta youth.

Fiscal Year 2023 Emergency Operations Center Program Grant

The Municipal Governance Team drafted legislation on behalf of the Mayor's Office of Emergency Preparedness to authorize the application and acceptance of a US Department of Homeland Security, Federal Emergency Management Agency (FEMA) grant in the amount of \$248,000 to be utilized for the City's Emergency Operations Center.

24/7 Gateway, LLC (Gateway Center) Donation

The Municipal Governance Team drafted legislation to authorize a \$700,000 donation from the Affordable Housing Trust Fund to Gateway Center to provide coordinated shelter and support services for individuals experiencing chronic homelessness in the city.

Goodr Memorandum of Understanding

The Municipal Governance Team drafted an MOU between the City and Goodr Grocery Store to support an initiative through Goodr's Hunger Relief Solutions to launch a free Goodr Grocery Store in William Walker Recreation Center, to serve hundreds of families experiencing food insecurity.

Victims of Crime Act (VOCA) Grant Legislation

The Municipal Governance Team drafted legislation on behalf of The Mayor's Office of International and Immigrant Affairs to accept the VOCA Assistance Grant award in the amount of \$82,840 from the Georgia Criminal Justice Coordinating Council for the provision of direct services to victims of violent crimes.

CDC Foundation/ Bloomberg Philanthropies Grant Legislation and Memorandum of Understanding (MOU)

The Municipal Governance Team drafted legislation and an MOU to authorize the City of Atlanta to apply for and accept a \$1M Bloomberg Public Art Challenge Grant from Bloomberg Philanthropies to develop art with a focus on civic challenges related to climate change, equity, food insecurity, gun violence, homelessness, public health and revitalization.

Resilient Cities Network Legislation

The Municipal Governance Team drafted legislation to authorize application and acceptance of a Resilient Community Impact Funds grant in the amount of \$50,000 for the purposes of development of a Thriving Neighborhood Index in partnership with The Center for Urban Research.

DEPARTMENT OF LABOR AND EMPLOYMENT SERVICES

Time Clock Policy & Procedures

The Municipal Governance Team collaborated with the Labor & Employment Team reviewing and revising the Human Resources Time Clock Policy & Procedures for Hourly Employees implementing new policy and procedures related to use of new WebClock Mobile and Hardware time keeping systems.





WorkSource Atlanta (WSA) Board Bylaws

The Municipal Governance Team reviewed and revised the WSA Board Bylaws pursuant to the establishment of the City's Department of Labor and Employment Services and the integration of the WorkSource Atlanta office.

DEPARTMENT OF GRANTS & COMMUNITY DEVELOPMENT

Hosea Feed the Hungry and Homeless, Inc. Legislation and Memorandum of Understanding (MOU)

The Municipal Governance Team drafted legislation and an MOU to authorize the Department of Grants to permit CohnReznick LLP to conduct an environmental review on behalf of Hosea for the US Department of Housing and Urban Development Economic Development Initiative (EDI) Community Funding Project (CPF) grant and for reimbursement by Hosea of all costs to the City associated with the environmental review.

Santa Fe Villas Legislation

The Municipal Governance Team drafted legislation to amend the FY2024 Intergovernmental Grant Fund budget to add \$892,236 to anticipations and appropriations and to authorize the City to enter into contractual agreements with G&S Santa Fe, LLC to provide rental subsidies at Santa Fe Villas to house one hundred (100) low-income formerly unhoused individuals under the City's Section 8 Moderate Rehabilitation Program.

FINANCE



The Municipal Governance Team assisted in the issuance of revenue bonds to finance construction and improvements to Hartsfield-Jackson Atlanta International Airport for the use of the public. The City of Atlanta issued \$707M in bonds on behalf of the airport to expand a concourse and make other improvements. The bonds will finance the widening of Concourse D, which is expected to take six years and cost \$1.4 billion. They will also fund a new parking garage and a fire station, among other projects that are included in the airport's capital plan, which calls for more than \$10 billion in spending through fiscal year 2029.



Atlanta Police Department (APD) Police Car Acquisition

The Municipal Governance Team coordinated with outside counsel and reviewed documents to support the Finance Department in amending the Master Lease Agreement with financial institution, JP Morgan Chase Bank, as necessary for the acquisition of replacement equipment and vehicles on behalf of APD in the amount of \$21M.

Atlanta Fire Rescue Department (AFRD) Fire Truck Acquisition

The Municipal Governance Team coordinated with outside counsel and reviewed documents to support the Finance Department in amending the Master Lease Agreement with financial institution, JP Morgan Chase Bank, as necessary for the acquisition of replacement equipment and fire trucks on behalf of AFRD in the amount of \$19M.

OPERATIONS DIVISION HIGHLIGHTS

Division Highlights: Operations – Labor and Employment

The Department of Law's Labor and Employment Team ("L&E") provided the following legal support to clients:

The Pregnant Workers Fairness Act (PWFA)

The PWFA became effective on June 27, 2023, extending the American with Disabilities Act (ADA) requirements to provide a reasonable accommodation to workers who are pregnant or affected by childbirth or related medical conditions. L&E provided a legal analysis of the PWFA's expansion of who qualifies for a reasonable accommodation. Under the PWFA, an employee may qualify for a reasonable accommodation if they are unable to perform an essential function of their job so long as that inability is temporary. L&E's advice ensures compliance with this evolving law and helps the City support pregnant workers.

Limiting the Hiring of Minors

L&E collaborated with the advice and counsel attorneys who support the Department of Procurement to evaluate various legal nuances related to solicitations and provisions imposing hiring limitations for minors under the age of 16. L&E advised on the federal, state, and local laws that regulate hiring minors and the potential legal implications under anti-discrimination laws for causing preferential hiring. L&E's advice is in furtherance of the City's codified provisions on Equal Employment Opportunity and Fair Private Employment.

Division Highlights: Operations – Labor and Employment

Benefits Consulting Services Legislation

L&E worked with the Department of Human Resources to prepare legislation expanding the scope of the benefits consulting services being provided by the firm, PRM South, Inc. The firm will assist the City in completing a comprehensive review of benefits offered to City employees and retirees as well as developing a strategic plan to manage costs for the next five years.





Division Highlights: Operations – Watershed

The Department of Law's Watershed Team provided the following legal support to clients:

Commercial Building Energy Efficiency

Provided advice on implementation and enforcement of the Commercial Building Energy Efficiency ordinance (Code Sec. 8-2222 *et seq.*).

U.S. EPA Grant

Drafted legislation to accept the U.S. EPA's Solar for All Grant and provided advice on the grant sub-awardee agreements necessary to implement the Solar for All Program.

African American Mayors Association Nutrition Access

Drafted legislation to apply for the African American Mayors Association Nutrition Access, Affordability, and Education Grant Program for a \$200,000 grant to improve access to nutritious food, improve the affordability of nutritious food, and provide nutrition education.

Reviewed and revised legislation to accept \$2M of allocated COVID supplemental funding from the United States Department of Transportation via the Atlanta Regional Commission for the Reconnecting Communities Pilot Grant Program for funding the planning of the STITCH, a transformational civic infrastructure project that will reconnect Downtown to Midtown Atlanta, and to enter into agreements with the United States Department of Transportation Federal Highway Administration and the Georgia Department of Transportation for implementation of grant acceptance and participation.



Key Legislation:

Sidewalk installation and repairs

Reviewed and revised legislation for sidewalk repairs and replacement at several locations on the North and South side of Martin Luther King Jr. Drive and for sidewalk installation on 17th Street.

City's litter receptacle program

Reviewed and revised legislation issuing multiple task orders: (1) to provide recommendations for an appropriate alternative site for yard trimming collection, (2) to conduct a study to provide recommendations for improvements to the City's litter receptacle program, and (3) to prepare a roadway visible litter characterization plan to implement the Keep America Beautiful 2020 National Litter Study Methodology and Protocol.

Qualified Contractor Permitting

The TPS legal team was integral in providing advice and counsel to the Atlanta Department of Transportation (ATLDOT) in the review and drafting of revisions to the departmental permit application process for installation of utilities. This improved process will ensure that contractors working within City of Atlanta right of way will enjoy a more streamlined and efficient permit application process, that only thoroughly vetted and qualified contractors will receive authorization to work within City of Atlanta right of way, and that the public will be well-informed concerning any necessary lane/sidewalk or road closures.

PATH 400 Trail in Sandy Springs

The TPS team provided advice and counsel to ATLDOT regarding five (5) separate agreements and associated legislation authorizing agreements with the City of Sandy Springs and the PATH 400 Foundation for the construction of PATH 400 multi-use trail extension along SR 400 from Loridans Drive within the city limits of Atlanta to the city limits of Sandy Springs to the south of Johnson Ferry Rd. The IGA, design and construction agreements authorize a project in excess of \$5.4 million.


