Safe and Secure Housing Initiative



- The Safe and Secure Housing team has been diligently working to ensure compliance and promote a safe environment for residents of multi-family dwellings.
- Since formation, the team has assisted with 28 property interventions and 8 properties have been brought into compliance.
- The team has participated in 14 joint details with Code Enforcement and held various meetings to continue collaboration efforts with other city agencies.
- The team continues to review and investigate data received from the Mayor's Office, Atlanta Police Department, councilmembers and various departments to ensure adequate measures are implemented.

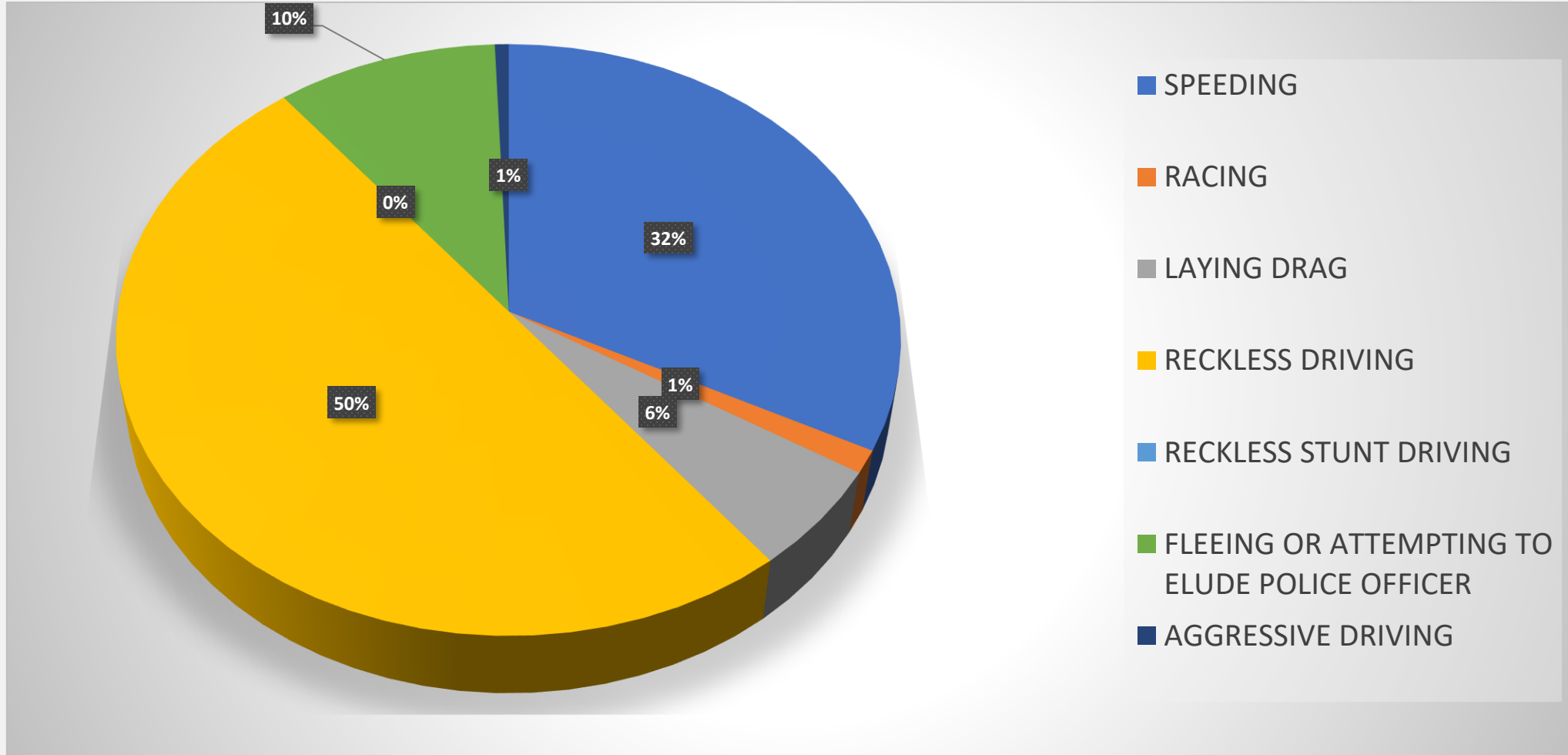

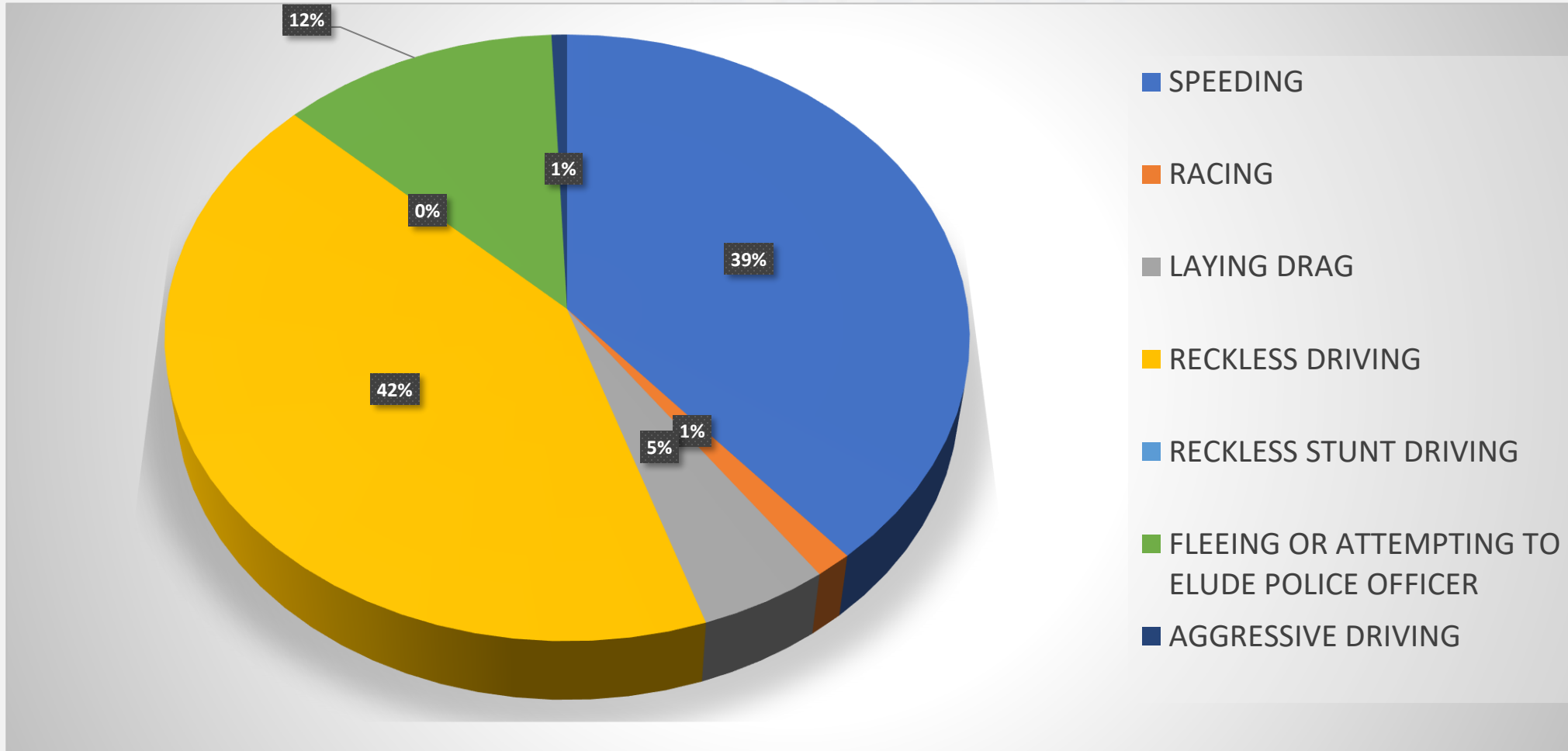

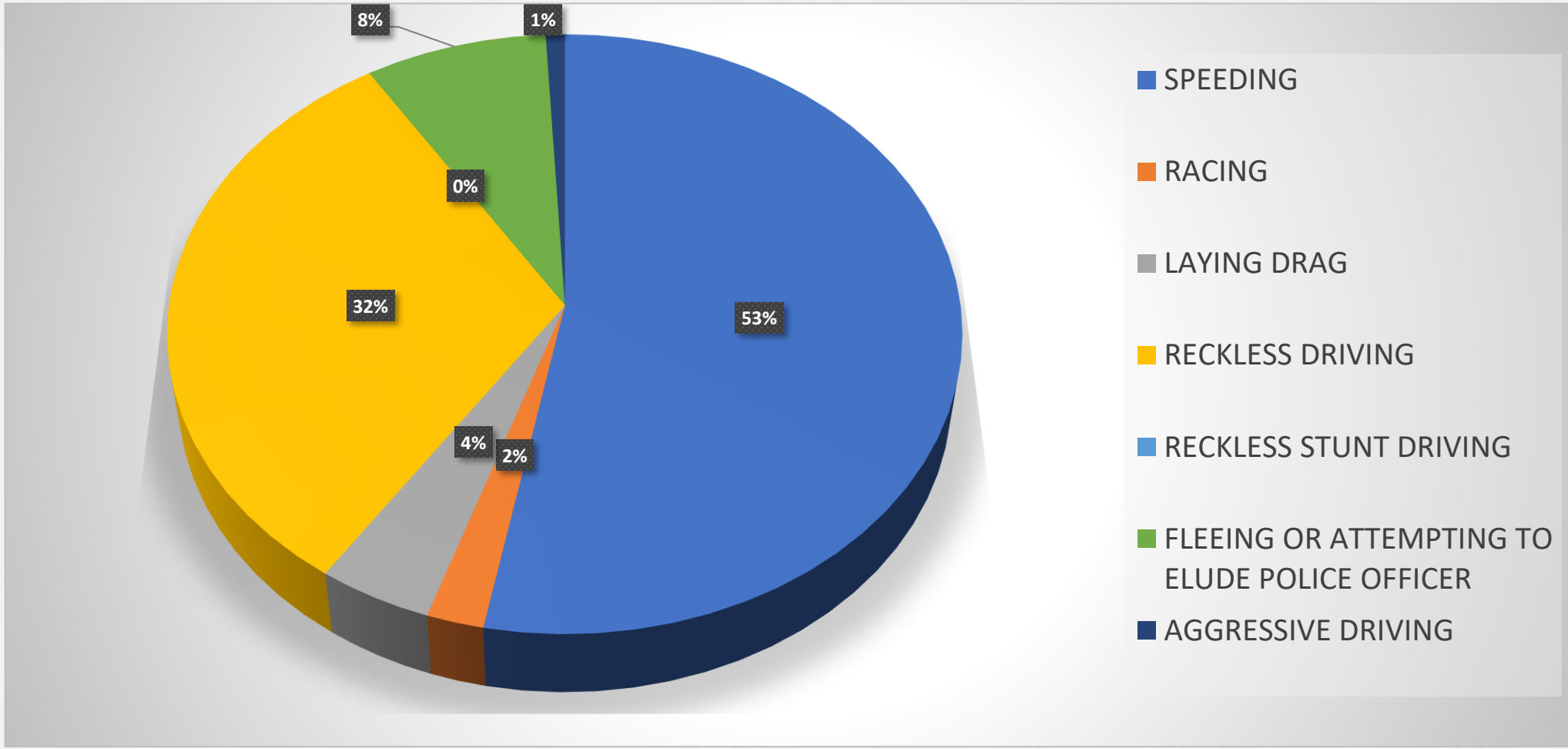

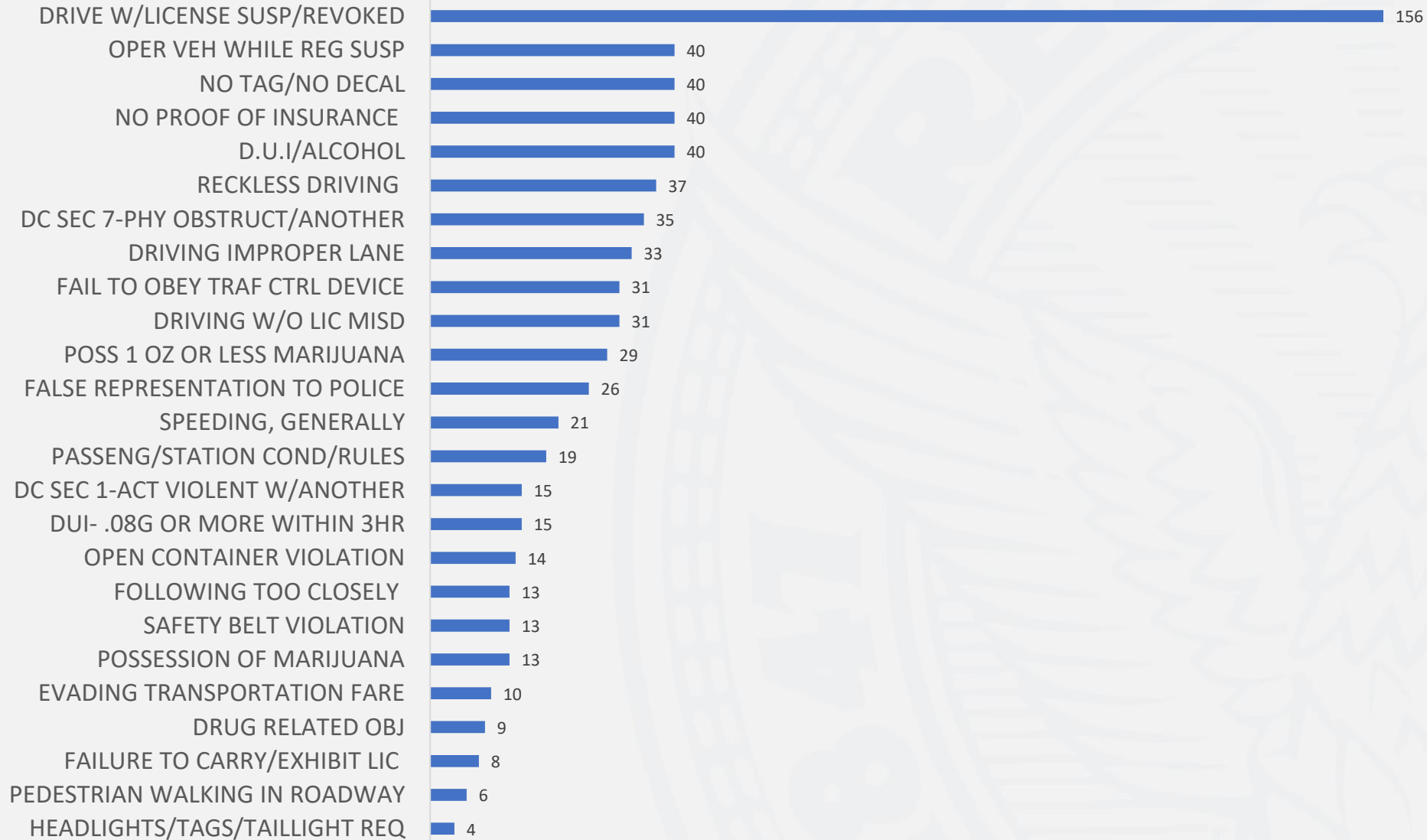
