




# Atlanta's Goal is to reach **ZERO traffic fatalities** by **2040**

- Pedestrian Safety quick-build implementation
  - Leading Pedestrian Intervals (LPIs)
  - Centerline Hardening
  - Daylighting/Micromobility Corrals
  - LOR for speed limit changes

#### **Year-to-Date Fatalities (2024)**


- Fatalities: 34



# Shared Micromobility Highlights



Shared micromobility trips totaled **2.4 million** in 2023; compared to 1.6 million in 2022

YTD in 2024 (Jan. 1- June 19, 2024), users took 913,923 trips, a 17% increase over the same period in 2023

Atlanta is a **top 10 city** for shared micromobility ridership in the US

Ongoing efforts to improve parking and provide organized corrals for micromobility; 5 installed todate








**61 Streets Resurfaced**

Delivering safety and drainage improvements throughout the Dekalb Avenue corridor.










# Capital Projects Update - Howell Mill Complete Street





