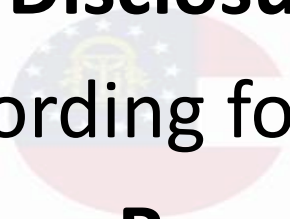

**Financial Disclosure System**

The City of Atlanta Financial Disclosure System is a web-based public disclosure system for ethics forms required under city law. City officials and employees are able to file their city financial disclosure statements online and the public is able to review the statements for actual and potential conflicts of interest.

**Latest News**

The 2019 City Financial Disclosure Statement will be available on **Friday, March 1, 2019**. The filing deadline is **Monday, April 1, 2019** and the grace period ends on **Monday, April 15, 2019**. Persons who file their annual statement after April 15 are delinquent filers and subject to a fine of \$50; which increases every two weeks that they fail to file. They may also be subject to other penalties.

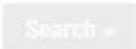
