**OFFICE OF THE MAYOR
AN ADMINISTRATIVE ORDER**

AN ADMINISTRATIVE ORDER DIRECTING THE COMMISSIONER OF THE DEPARTMENT OF WATERSHED MANAGEMENT TO REFRAIN FROM TAKING ANY ACTION WHICH WOULD RESULT IN THE TERMINATION OF WATER SERVICES TO ANY WATERSHED MANAGEMENT CUSTOMER, DUE TO NON-PAYMENT, FROM THE DATE OF EXECUTION OF THIS ORDER THROUGH JANUARY 31, 2021.

WHEREAS, like much of the world the United States, the State of Georgia, and the City of Atlanta are currently responding to an outbreak of respiratory disease caused by a novel coronavirus named “SARS-CoV-2” and the disease it causes named “coronavirus disease 2019” (abbreviated “COVID-19”); and

WHEREAS, on March 11, 2020 the World Health Organization declared the COVID-19 outbreak a pandemic; and

WHEREAS, on March 13, 2020 the President of the United States announced a national emergency in response to the COVID-19 pandemic, which included two emergency declarations: one under the National Emergencies Act and one under the Stafford Disaster Relief and Emergency Assistance Act; and

WHEREAS, on March 14, 2020 Governor Brian Kemp signed a public health state of emergency to address the COVID-19 pandemic through assisting health and emergency management officials across Georgia by deploying all available resources for the mitigation and treatment of COVID-19; and

WHEREAS, due to the COVID-19 pandemic, on March 16, I declared there to be an emergency in existence within the City of Atlanta pursuant to Section 2-181(a) of the City of Atlanta Code of Ordinances; and

WHEREAS, on April 2, 2020, Governor Brian Kemp signed an Executive Order to Ensure a Safe and Healthy Georgia (Governor’s Executive Order 04.02.20.01) to address the COVID-19 pandemic by implementing temporary actions necessary and appropriate to protect the health, safety, and welfare of Georgia’s residents and visitors; and

WHEREAS, subsequently, Governor Kemp has issued a series of Executive Orders which amend and revise the temporary action necessary and appropriate to protect the health, safety, and welfare of Georgia’s residents and visitors; and

WHEREAS, as a result of the COVID-19 pandemic, the economy of the City of Atlanta has been severely impacted; and

WHEREAS, through its Department of Watershed Management, the City of Atlanta provides customers with reliable, high quality water services while protecting and enhancing public health; and

WHEREAS, as a result of the economic effects of the COVID-19 pandemic many customers of the Department of Watershed Management may be suffering considerable financial hardships; and

WHEREAS, to help mitigate the negative impacts on those who may suffer considerable financial hardships as a result of the COVID-19 pandemic, on March 11, 2020 I issued Administrative Order 2020-03 by which I directed the Commissioner of the Department of Watershed Management to refrain from taking any action which would result in the termination of water services to any Watershed Management customer, due to non-payment; and

WHEREAS, due to the persistence of the COVID-19 pandemic crisis throughout 2020, I have issued renewals of this Administrative Order which extended this moratorium, such that it shall remain in effect through December 31, 2020; and

WHEREAS, due to the persistence of the COVID-19 pandemic crisis, and the continued critical need to assist the mitigation of the considerable financial hardships resulting therefrom, I am hereby directing the Commissioner of the Department of Watershed Management to refrain from taking any action which would result in the termination of water services to any Watershed Management customer, due to non-payment, from the date of execution of this order through January 31, 2021.

NOW, THEREFORE, BY THE POWER VESTED IN ME AS MAYOR OF THE CITY OF ATLANTA, pursuant to Section 3-104 of the City of Atlanta Charter and Section 2-182(4) of the City of Atlanta Code of Ordinances, it is hereby ordered as follows:


