SUBJECT: Quarterly Update – Atlanta Regional Commission

This update provides an overview of Atlanta Regional Commission (ARC) activities since last quarterly update on December 16, 2020.

### **Meetings**

ARC monthly meetings are still conducted remotely due to COVID-19. The following meetings were attended or are upcoming:

- Board Meetings 1/13, next meeting will take place 3/10/2021
- Special Board Briefing (Regional Development Plan) will take place 3/2/2021
- Pension Board of Trustees First Quarterly Meeting tentatively scheduled for 3/24/2021

#### **Kev Issues**

The following key issues have been discussed during this quarter:

- FY20 Aging 2020 Annual Report. Highlights include:
  - o Goal is still to maximize the independence, health, and well-being for older persons, individuals with disabilities and their partners.
  - o 792,000 people age 60 or older lived in metro Atlanta in 2019 (approximately 1 in 8). We expect that number to grow to 1.2M by 2030 (approximately 1 in 4).
  - Key focus areas for ARC will be accessible transportation, pedestrian-friendly neighborhoods, and affordable housing for every phase of life.
  - O Demand for programmatic services increased in 2020 due to COVID-19. ARC allocated \$5.4M regionwide in federal dollars and philanthropic funding to the provision of services enabling this segment of our population to continue living as independently as possible (counseling, in-home meals, wellness programs, legal assistance, etc).
  - ARC's Aging & Independent Services Group will continue advocating for services at the federal, state, and local levels.

### • Green Communities. Highlights include:

- Green Communities is a voluntary certification program encouraging local governments to implement measures reducing their environmental footprint. The program's target areas are government buildings, fleets, and practices; community engagement; and public education on sustainability issues.
- Local governments earn points by implementing sustainable policies and practices across a range of categories.
- Adopted a resolution with goal of full Green Communities certification within 2 years.
- The City of Atlanta is currently certified Gold status (Platinum is the highest certification level).

## • Economic Impact of COVID-19. Highlights include:

- We discussed what we "think" we know about the impacts of COVID-19 upon the region's economy.
- In January, cases were trending upward driven most likely by people spending increased amounts of time indoors at places which were not their homes, for extended periods of time.
- Employment numbers are improving but still have not reached pre-pandemic levels. The only sectors which seem to be pandemic-proof are Trade, Transportation, and Utilities.
- Only 10% of small businesses report a return to normal as others continue to struggle in the pandemic economy.
- o Approximately 27% of licensed childcare facilities and homes are closed. Some reports indicate that roughly 50% of these facilities may never reopen.
- When the national moratorium ends, approximately 80,000 renter households throughout the region will be under severe distress.
- The shift to virtual learning at the end of the school year contributed to declines in reading and math proficiency equaling about 2 years of learning loss.
- Households are saving more money during the pandemic which may point toward an economic resurgence in late 2021 barring any further unanticipated circumstances.
- What we know for sure is that persons of color are experiencing the greatest adverse impacts due to the dual public health and economic crises.

# • Workforce Presentation. Highlights include:

- Atlanta Regional Workforce Development Board directs the investment of \$12-15 million annually in 7 counties.
- Goals are to ensure region employers have a trained workforce; ensure residents in the Atlanta region have access to high-quality labor market information, training, employment services, along with educational and career advancement
- o ARC will also support workforce development initiatives encompassing all 10 counties within Region 3.
