

Coronavirus COVID-19 Pandemic

- In accordance with the City of Atlanta's rollback of its reopening plan to *Phase Two*, the Atlanta City Detention Center (ACDC) remains closed to the general public.
- Currently, only essential personnel, detainees, contractors, mental health service providers, vendors, attorneys and individuals conducting essential business are allowed inside the facility, i.e. paying a cash bond for a detainee.




Coronavirus COVID-19 Pandemic

- COVID-19 safety precautions for staff and detainees include: proper hand washing, use of hand sanitizer, providing/wearing masks (N95, KN95, surgical), contactless temperature checks before entrance to facility (and again periodically for detainees while in custody) and practicing social distancing as much as possible
- Continue to encourage staff to get tested and vaccinated
