## FUNDING

Bank balance 52,920.18

People TV Inc. applied and received a loan from the SBA July 2020 in the amount of \$107,500.00 during that time we were in negotiation with the City of Atlanta for a new contract. During the (9) months that it took to finalize said agreement payments to People TV Inc were stopped. Although we continued to provide service per the franchise agreement. The only way we were able to survive without payment from the City of Atlanta was to use the money from the SBA Loan. That loan money was earmarked for improvements and upgrades for People TV Inc. and to have funds set aside for our relocation. So instead of having a sound financial base with the SBA Loan the money was used to continue running People TV Inc. The set back of not getting paid diminished almost all the SBA Loan and our nest egg for relocation. Without the SBA Loan our ability to maintain a functional facility required by the franchise agreement would not had happened.

Once again and every time I give a report, I will be asking for the unpaid balance of \$125,000. The last payment received was June 2020. So from June 2020 until February 2021 are owed to People TV Inc.

$$15,625 \times 8 = \$125,000.$$

## CHALLENGES TO THE BOARD

People TV Inc.'s Board faces direct breakdowns, mainly from the actions of outside individuals who hold themselves as stakeholders. Lack of interest, commitment and engagement is a direct effect of the constant badgering from them. As we continue to uphold the high standards set forth in accordance with the new agreement between the City of Atlanta and People TV Inc., we now have 10 Board members. None of which are appointee from the Mayors office or the City council.

I respectfully ask that you fulfill these vacant seats as soon as possible. We are in dire need of competent individuals that has the influence, time and ability to serve without prejudice on People TV Inc.'s Board of Directors.
