



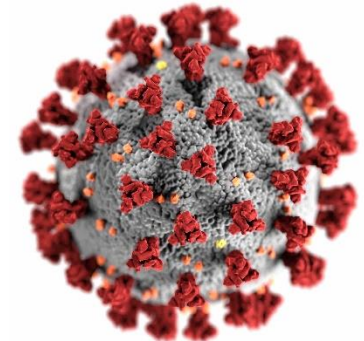

Coronavirus COVID-19 Pandemic

- The City of Atlanta has not fully reopened city facilities. Therefore, the Atlanta City Detention Center (ACDC) remains closed to the general public.
- Currently, only essential internal and external customers conducting business are allowed inside the facility.
- COVID-19 safety precautions for staff, detainees and general public include: contactless temperature checks, mask mandate, and social distancing as outlined by the CDC and the City of Atlanta.
- Known cases of COVID-19 (March 2020-Present)
 - City of Atlanta Department of Corrections personnel – 62
 - Detainees – 2

SOMEONE CARES ATLANTA

Under the leadership of Ronnie Bass and in partnership with ACDC's team, Someone Cares offers HIV testing to interested detainees once weekly. The purpose is to provide Wholeness Health and Wellness to our community.

Additional assistance provided:

- Housing
- Substance abuse
- Mental Health Counseling
- Access to medications

Emory Mental Health

Mental Health services are provided to detainees in collaboration with Emory/Grady Fellows from the Department of Psychiatry and Behavioral Sciences of Emory University School of Medicine.

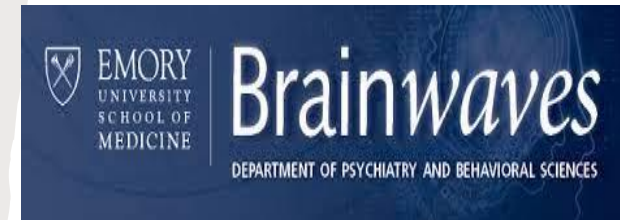
- Provided psychiatric services
 - psychiatric evaluation, medication management, crisis counseling, and inpatient referral, if needed.
- Provides for the care & treatment of persons who are mentally ill while in custody.
- Coordinates Psych Clinic Visits twice a week through partnership with Grady/Emory Psychiatrists
- With inmate approval, the Mental Health team coordinates appropriate mental health care with their outpatient provider and family.
- Collaborate with other agencies for example, the Public Defenders office, Homeless Court Staff, Grady Psychiatric team, and other outpatient mental health agencies to coordinate aftercare services for successful inmate release.

Inspections

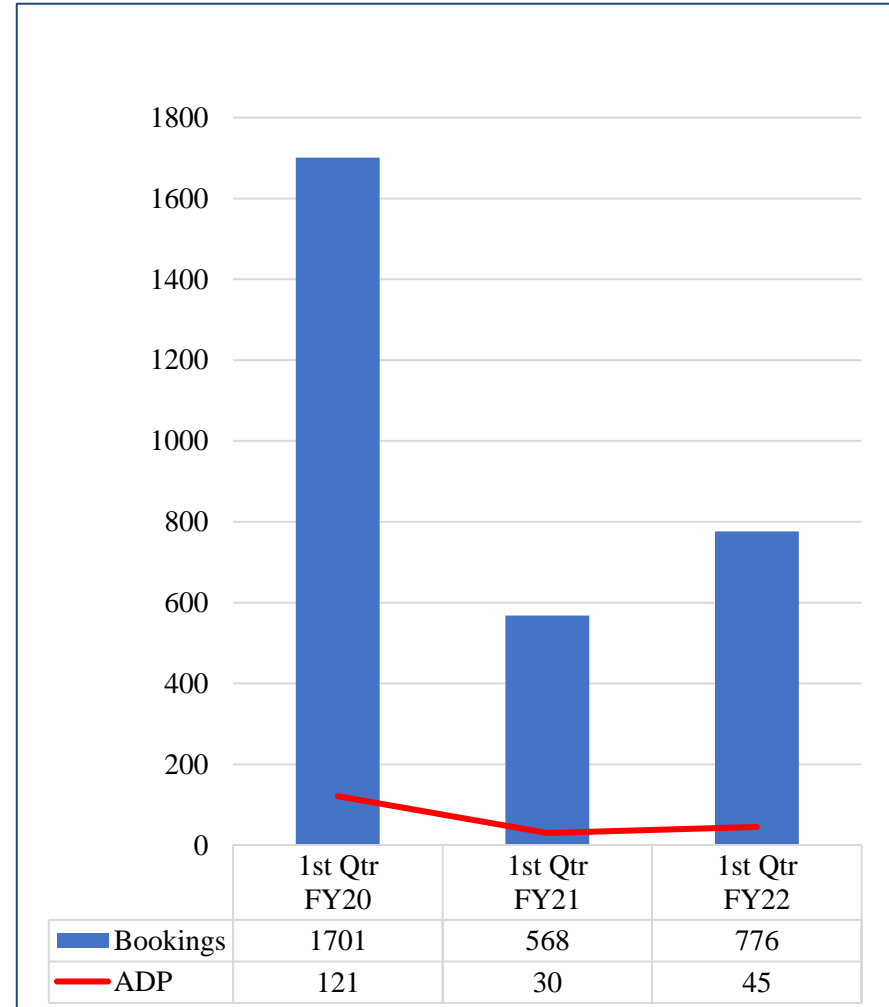
- June 25th: Passed the Annual Elevator Inspection conducted by the State Fire Marshal Safety Inspector.

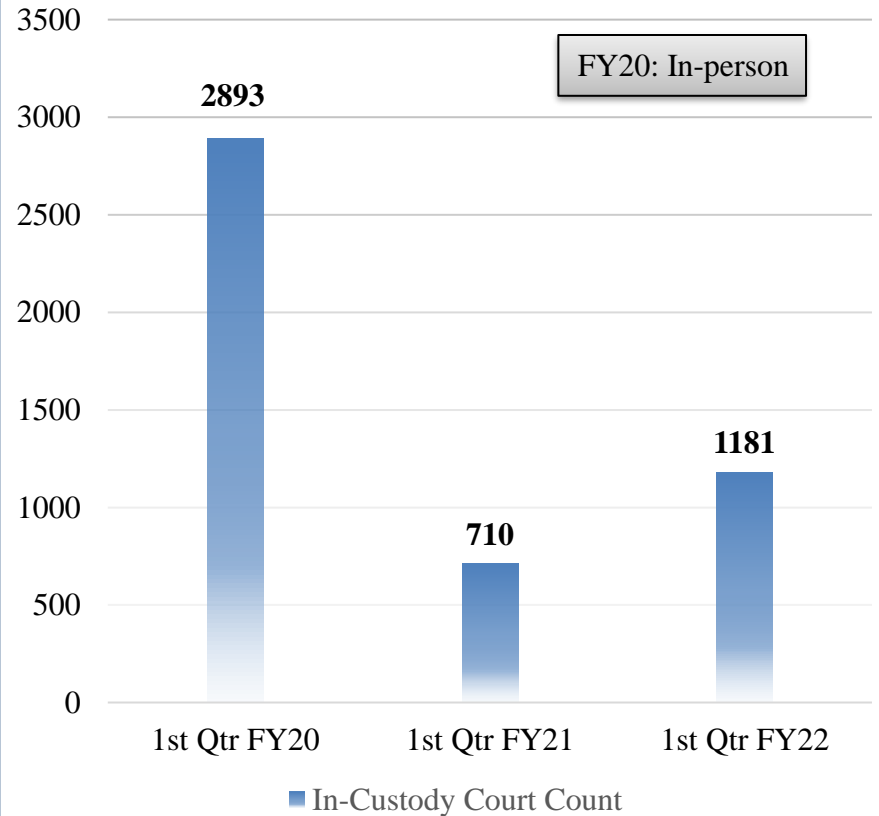
