

# Department's Strategy of Operations for FY23



#### **Personnel Challenges:**

Nationally, Criminal Justice Institutions are facing an employment crisis as a result of the Covid -19 Pandemic influence on employment market conditions.

The department has experienced a higher than normal turnover rate in essential functions:

- Loss of 8 key employees 6 Attorneys, 1 Senior Investigator, and 1 Client Advocate (20%)
- Onboarded 6 new employees
- 9 current vacancies

Many Criminal Justice Institutions have answered by significantly increasing their salary ranges.

#### **Personnel Deployment Strategies:**

The Office of the Public Defender will continue to advocate for all clients zealously and in a holistic way.

The department will implement strategies to retain staff that have critical expertise and experience. This strategy will include necessary salary adjustments and promotions.

The department will implement recruitment, hiring, and retention strategies that may include adjusting entry pay scales to attract new talent.
